Meeting Rules:

The Presbytery has adopted **Electronic Meeting Standing Rules**.

Additional provisions in the <u>Bylaws</u> and general <u>Standing Rules</u> may come into play, particularly during the nomination and election process.

Use of Zoom features in the meeting:

Remain muted unless you either:

- a. are recognized by the moderator to speak OR
- b. have a point of order or parliamentary inquiry

then use the unmute button (or *6) on a telephone in order to speak.

To **seek recognition** in order to speak: use the raise hand function (on a telephone use *9 to raise or lower hand). If a large number of people are seeking recognition, the moderator may ask persons seeking recognition to use the chat feature to indicate the purpose for recognition by typing one of the following words:

For (to speak in favor)

Against (to speak against)

Other (for another purpose-e.g. amend, refer, close debate, divide the question, etc.).

To seek recognition for Points of Order or Parliamentary Inquiries unmute and address the chair.

This will enable the moderator to alternate between those speaking For and Against while recognizing Other speakers in the order they sought recognition with the raise hand function.

Voting will ordinarily use a Zoom poll which appears on the screen with the ability to click yes or no to register your vote. Those who cannot access the poll can use the raise hand function during the vote (on a telephone use *9 to raise your hand).

Rationale

The Presbytery Leadership Commission adopted a motion to hold four stated meetings per year for 2024-2025, alternating between on-line and in-person meetings which requires adding a January meeting. By adding more flexibility for the Spring and Fall meetings in terms of the month of the meeting this permits meetings later in the Spring and earlier in the Fall (April &October) which allows for better travel weather when the Lenten/Easter cycle permits it. Stated meetings can only be established in the bylaws.

5.) 2024 – 2025 EQUALIZATION FORMULA [Consent Agenda]

3.) Harassment Policy

At the November 28, 2023, Special Meeting of Presbytery, we adopted an [sic] Harassment Policy. Presbyters raised concerns that the policy is incomplete because it confines its scope to the Presbytery's work environment and does not address harassment that may occur in meetings or other events of the presbytery. The Stated Clerk promised to take the comments and, with the help of Personnel & Administration, bring back a revised policy in 2024. Since then, the Stated Clerk has identified two other harassment policies from the Presbyteries of Milwaukee and Philadelphia (More policies will be coming online this summer- consult Google for updates). The Stated Clerk has two goals for the revision - the first is to incorporate language that widens the scope of the policy to all presbytery environments and the second is to align the reporting process where possible with revisions to the Sexual Misconduct Prevention Policy of the Presbytery. The Harassment policy is still in force and the Stated Clerk believes that a proposed revision to the policy will be ready for the November Stated Meeting.



APPENDIX A

2024-2025 EQUALIZATION FORMULA

This proposed Equalization Formula reports the number of Ruling Elder Commissioners that each congregation may send to presbytery meetings for the period after adjournment of the July, 2024, Stated Meeting through the end of the summer 2025 Stated Meeting. This formula aims to achieve numerical parity between Minister Members and Ruling Elder Commissioners who vote at meetings in accordance with G-3.0301.

The number of Ruling Elder Commissioners each congregation may send is listed below. Numbers are based on reported 12/31/23 membership. Every congregation receives 2 commissioners plus an additional commissioner for every 250 members.

Additionally, each congregation is invited and authorized to send a racial/ethnic elder commissioner in addition to those authorized based on the above formula in an effort to redress racial ethnic balance.

REPORT OF THE TREASURER

Introduction to Presbytery of the Cascades 2024 Financial Statements

The Statement of Financial Position and the Statement of Financial Activities below cover January through May 2024 and are generated from our ledger in Quickbooks. "Statement of Financial Position" is used by non-profits for "Balance Sheet" and "Statement of Financial Activities" is used by non-profits for "Income and Loss statement".

In 2024 we continue to track Program vs. Administrative income on the statement of financial activities. We plan to consolidate the program and administrative income reporting in 2025.

Some commonly used acronyms in the account names on these reports:

FF&E Furniture, Fixtures and Equipment

ICC Inter Church Center, the office building in Portland owned in part by the Presbytery and shared by local offices of four other denominations

MDC Short term fixed interest investment (think a Certificate of Deposit) held at the Synod of the Pacific

N.A. Net Assets

NCF New Covenant Funds. New Covenant Funds are stock and bond investments held in the New Covenant Balanced Mutual Fund

NMT New Ministries Team

PPG Presbyterian Partnership Giving

PC Presbyterian Church

PF Account at the Presbyterian Foundation

PF (number) – Account at the Presbyterian Foundation whose account number ends in the three digits in the account name.

Fidelity Investments Main and Oakland Perpetual Funds are stock and bond investments under management of Headwater Investment Consulting, Inc.



The New Covenant and Fidelity Investments together make up the bulk of our Reserves and Endowment.

As a reminder, the **Administrative Budget** is funded primarily by Per Capita payments from each congregation in the Presbytery. Per Capita payments support the Presbytery's administrative work. These funds:

- Fund the Stated Clerk's salary and half of the Administrative Manager's salary, as well as the Media Technician's salary
- Allow both the Presbytery and Presbytery Leadership Commission to meet
- Enable the Board of Trustees to manage the financial affairs of the Presbytery
- Fund any legal costs of the Presbytery and any other professional services required
- Pays for office overhead (phones, supplies, postage, storage, etc.)
- Pay administrative costs for Presbytery committee meetings meals, lodging and mileage

This Presbytery honors all Per Capita amounts payable to Synod and General Assembly without regard to whether a congregation withholds or pays less than its full share. Again, Per Capita is split up: of the total of \$45.60, \$30.58 is given to Cascades Presbytery, \$5.22 to the Synod and \$9.80 to General Assembly.

The **Program Budget** is supported primarily though the Presbyterian Partnership Giving (**PPG**), which is voluntary by our member churches. It includes the many activities that allow Cascades Presbytery to provide its mission, for example:

- Fund Presbytery staff to support local congregations and general administrative duties. This
 includes the two executive Presbyters, one half of the Administrative Manager's salary,
 the Bookkeeper, Commission on Ministry Team Leads, Missional Resource Manager, and
 Communications Manager
- Financial assistance to churches
- Emergency assistance to churches of all sizes (e.g., Barnabas Funds)
- Presbytery functioning in support of local congregations
- Care of congregations and pastors

We currently hold real estate in the form that came from dissolved congregations: the former Cherry Park, Colonial Heights and Cooper Mountain Presbyterian Churches. Cherry Park is currently generating revenue and so under Generally Accepted Accounting Principles (GAAP), we must take depreciation against them each year.

Summary Questions

Are We Within Budget?

As of June 1st, our budget is currently not running a deficit. While there is a deficit on the program side of the budget, the administrative budget is ahead of expenses.

Under the soon to be adopted combined budget model, we are at this time not running a deficit and ahead of our expenses by ~\$28,000. However, it is important to note that the Presbytery's income is seasonal (via per capita) and typically weighted toward the beginning of the year (we have already received 61% of our per capita).

Board of Trustees Report July 2024 Presbytery Meeting

The Board of Trustees held one stated and one special meeting during this period. In addition to approving or renewing a number of leases and loans for our congregations, the board:

- Accepted an offer to purchase the former Colonial Heights/Common Ground church property. The property was offered at \$1.75 million, but the agreed sale price is \$1.6 million due to the damage the property sustained after it was put on the market. The buyer intends to create a music school on the property. Due to the poor condition of the building, the expense of repairs the insurance company would not cover, the high holding cost for the property, and the dissolved congregation's debts, this sale will generate far less income than it would have if it had been sold last year.
- Resumed processing applications for Barnabas Grants. At the April 2024 Presbytery Meeting, the membership voted to allocate one third of the proceeds from the sale of the Mt Laki church property to the Barnabas Grant fund. This allows the Trustees to resume issuing grants to congregations that need financial help to make unanticipated repairs, etc. The timeline for applying for Barnabas Grants was published in Cascades Connections and is posted on the POTC Website. Applications are being accepted from July 1 to September 5, 2024. This allows all the grants to be reviewed by the Property Committee prior to the next stated meeting of the full Board, where the grants will be approved. The application form is posted on the POTC website at this link https://cascadespresbytery.org/grants/.
- Continued dialogue with the congregations that participated in the Partners for Sacred Places cohort about their progress and needs. This resulted in the POTC staff and our lawyer providing information on the tax implications of renting to a for-profit tenant and writing a few paragraphs that can be inserted into a lease to cover necessary items when leasing to a for-profit tenant. This information can be found under the "Resource" tab on the POTC website. The Trustees also determined it would be possible to use Vitality Grant money to address mutual needs for services for this group if they identify them. This would allow the cohort congregations to obtain the same service from one grant. Writing one grant request to fund the same service for multiple congregations is expected to save time and energy.

Partners for Sacred Places is exploring the possibility of holding a workshop in the Pacific Seattle area in January of 2025. We asked if that cohort would be open to congregations in southern Washington or from Oregon and indications to date are encouraging.

Presbytery of the Cascades 2025 Per Capita Update

The Presbytery of the Cascades proposed 2025 per capita figure will be announced at the July 2024 Stated Meeting. The goal of the Board of Trustees and Budget and Finance Committee is to keep per capita under \$50 per member in 2025, however a finalized figure recommendation is dependent on what the General Assembly will decide for per capita at the upcoming GA meeting. While we're unable to provide a definite number at the time of this report, more details on per capita will be announced at the Stated Meeting on July 12th.

FOR ACTION

The Board of Trustees brings one motion to the membership at this meeting: [Consent Agenda #5]

Approve a request from First Presbyterian, Newport, to sell a portion of its property to Habitat for Humanity.

This sale will allow Habitat for Humanity to construct five affordable housing units on approximately one-acre of land fronting a residential street. The residents of the affordable housing units Habitat for humanity intends to build will become the next-door neighbors to the existing church building. Under the terms of this sale, if for any reason the housing developer is unable to use the property, it will revert to church ownership. Proceeds from the sale will be used to create a fund for maintenance of the church property.

1.) Board of Pensions Benefits for Ministers and Commissioned Ruling Elders
With the changes to the Board of Pensions benefits program effective Jan. 1, 2025,
clarity was needed for minimum benefits in the new benefits structure. A workgroup appointed by COM-CC studied the changes and their impact on pastors and congregations within the Presbytery of the Cascades and made the following recommendations that were presented to COM-CC.

Amend the Commission on Ministry Manual by inserting the following clarification regarding Board of Pensions Benefits:

The 2025 Minimum Board of Pensions standard for Ministers and Commissioned Ruling Elders ("CREs") is as follows:

2.) Pulpit Supply and Meeting Moderating Minimums

The Commission on Ministry Coordinating Council recommends that the Presbytery of the Cascades adopt a new minimum standard for honorariums by **amending the Commission on Ministry Manual** (remove text in strikeout, insert words in **bold**):

Minimum guidelines are between \$50 \$75 and \$150 \$200 for moderating session or congregational meetings based on length of meeting and need for advanced preparation, plus mileage/travel reimbursement; with presbytery covering mileage over 50 round trip miles and presbytery also covering lodging and meal costs up to \$175 for distances of more than 200 total miles or extraordinary circumstances. Minimum guidelines for preaching are \$75 \$200 \$150 plus mileage/travel.

By Presbytery rule, the minimum FTE compensation for Pastors, Elders Commissioned to serve as Pastors (CRE'S) and Certified Christian Educators for 2025 is \$57,096 (up from \$56,129 in 2024, roughly a 1.7% increase) and Additionally, the Commission on Ministry Coordinating Commission recommends that all Pastors, Elders Commissioned to serve as Pastors, and Certified Christian Educators receive a COLA of 3.7% based on the CPI-U West.

INTRODUCTION AND OVERVIEW OF COMMISSION ON MINISTRY

The Book of Order states that each presbytery shall develop mechanisms and processes:

- to serve as pastor and counselor to its ministers, commissioned pastors and certified Christian educators;
- to facilitate the relations between the presbytery and its congregations, pastors and certified Christian educators;
- to settle difficulties on behalf of the presbytery where possible and expedient."[G-3.0307]

Cascades Presbytery has delegated authority in these areas to five commissions: a Commission on Ministry (COM) for each of the four regions and the Commission on Ministry Coordinating Commission (COM-CC).



Each of the four **regional COM** is composed of equal numbers of ministers and elders from the region. These commissions have been authorized to:

- receive, dismiss and oversee minister members;
- approve and dissolve calls for pastoral service and invitations for temporary pastoral service;
- provide oversight of congregations without pastors;
- approve the establishment and elimination of pastoral positions;
- establish administrative commissions to ordain or install ministers of Word and Sacrament.

The **COM-CC** consists of the four regional COM chairs and presbytery elected staff. This commission:

- coordinates the work of the regions;
- deals with any presbytery-wide issues related to ministry;
- acts as a clearing board for appeals on decisions of regional COMs.

The Commissions on Ministry have established a subcommittee responsible for the training and oversight of the presbytery's Commissioned Ruling Elders, known as the **Commissioned Ruling Elders Coordinating Committee (CRE-CC)**. The CRE-CC is comprised of one representative from each of the regional COMs, as well as one representative of the Commission on Preparation for Ministry (CPM), and is supported by the Advocate for Congregations and Clergy.

The Commissions on Ministry have also established <u>two non-regional based teams</u>, each led by a paid team leader hired by the presbytery. These teams support the work of the Commissions on Ministry in **Conflict Management and Care of Pastors.** Here are the 2 Commission on Ministry **Support Team Leaders**:

Conflict Management: Rev. Dr. Sarah Sanderson-Doughty, Teaching Elder, St. Andrews PC, Portland **Pastoral Care:** Rev. Susan Graham, Teaching Elder, Lake Grove PC, Lake Oswego, OR

The commissions bring for **presbytery** action motions related to:

- permitting associate pastors to be eligible to serve as the next installed pastor or co-pastor;
- permitting a Minister of the Word and Sacrament employed in a stated supply pastoral relationship to be eligible to serve as the next installed pastor, co-pastor, or associate pastor;
- examining certified candidates for ministry in order that they might be ordained and installed in an approved call;
- receiving ministers of Word and Sacrament from other denominations for called positions;
- requests for administrative commissions for purposes other than ordination and installation.

In their work and recommendations, the Commission on Ministry is guided by the provisions of the Book of Order and Commission on Ministry policies as approved by the Presbytery of the Cascades as found in the Commission on Ministry Manual.

During all pastoral contracts and calls, the Commission on Ministry guides churches to demonstrate a commitment to our Affirmative Action and Equal Employment Opportunity policies, which can be found in section 2.3d, Appendix 6F and section 7.6 of the COM Manual.



These policies affirm that "The Presbyterian Church (USA) is firmly committed at the General Assembly, synod and presbytery levels to the principle of inclusiveness. The mid-councils of our church believe that the spirit of Jesus Christ and the Gospel calls us and enables us to be inclusive of all who will respond to Christ's call..." The affirmative action "involves positive action, sincere effort, deliberately including for consideration and inviting all whom Christ has called to serve."

To guide this effort, the COM Manual outlines the following procedures which shall be maintained in the calling of pastors:

- a. The Commission on Ministry (COM) liaison consults with the session, congregation and the Pastor Nominating Committee (PNC) about their responsibility for AA/EEO, and assists them in developing a plan of implementation. It is recommended that arrangements be made for an affirmative action interpreter to visit, to talk about the issues and their experience, and to answer questions. In order to proceed to pastor search, the session, congregation and the PNC shall each take action and authorize the clerk, moderator of the session, and chairperson of the PNC to sign off on the Ministry Information Form (MIF).
- b. The COM shall assist the PNC in developing non-discriminatory criteria for the selection of the pastor. Discrimination based on racial ethnicity, age, gender, marital condition or disability is illegal.
- c. The COM liaison, while working with the PNC shall, when necessary, challenge the members to stay with their commitment and shall, when appropriate, help them face questions and feelings which arise.
- d. Before the PNC presents a name to the congregation, the COM liaison shall be clear that they are prepared to certify that the AA/EEO commitment has been followed in good faith.
- e. The COM liaison shall certify to the regional COM, who shall certify to presbytery that the requirements of AA/EEO have been met (see Appendix 6F: Exhibit 1 of the COM Manual).

For pastoral searches for Temporary Pastoral Positions, such as for Interim and Supply Pastors, that do not involve a Pastor Nominating Committee, the Commission on Ministry similarly takes steps "to assure that every search is conducted to fulfill AA/EEO requirements. Thus, every pastor, regardless of race, ethnic origin, sex, age, marital status, or disability will be assured equal consideration by each search committee."

Our Presbytery's commitment to Affirmative Action and Equal Employment is strong, and in each search, the Commission on Ministry strives to bolster this commitment by ensuring churches are aware of the policies, that the policies are being followed, and that together, our hiring practices are reflecting our mutual commitment to be inclusive to all who have sensed and responded to Christ's call.

I believe in Yahweh who is Father, Son, and Holy Spirit. Out of love, God created all that is—seen and unseen—to share in the triune life. I believe that this God, in the person of the Son through the power of the Holy Spirit became a human being born of a virgin amongst the chosen people of Israel and was named Jesus. This was testified to by the prophets of the inspired scriptures who spoke to our ancestors of a coming Messiah who would save Israel. This Jesus was and is fully the God of Israel and fully human. In the power of the Holy Spirit He lived without sin as Israel's Messiah, suffered, was executed on a cross, was resurrected, and ascended into heaven on behalf of the God's covenant with Israel and all of humanity. By His life, death, and resurrection all of creation has been incorporated into the Triune life of the LORD, the God of Israel.

I believe that by the Holy Spirit, God called the church catholic into being to participate in the resurrected life of Christ. The church witnesses to how God through the chosen people in Christ redeemed humanity from the powers of death. Through the Holy Spirit we are united with God in Jesus and through the Sacraments of Communion and Baptism are drawn deeper into this union. In Baptism we receive the sign and seal of our participation in Christ's life, death, and resurrection. Through Communion we share in Christ's self-offering and are drawn deeper into God's covenant of grace.

I believe that the Old and New Testaments witness to God's revelation in Jesus Christ. These scriptures were inspired by the Holy Spirit and are essential for the life of the church. I believe that we await a bodily resurrection from the dead as result of our participation in Jesus' bodily resurrection. A day will come when God, the Triune God of Israel will come again in glory and power to judge the living and the dead according to the love shown to humanity through God's covenant in Jesus' life, death, and resurrection.

Summary of Work and Educational History

Over the past few years, my work has been teaching—largely in minoritized settings and for the sake of those preparing for Christian ministry. I was ordained to specialized ministry for this calling in 2019. While most of my teaching work took place during my PhD program, the tone was set by two positions. The first position was as with AmeriCorps as a teacher in a minimum-security detention facility for undocumented youth from Central America and Mexico (2009). This position set the tone for much of what I have discerned the focus of my work as a Chicano minister and scholar to be—democratizing education for the sake of the marginalized. Then, while in Seminary, I was a TA for an intensive course in Guatemala for the United Methodist Church (2015). This role placed an emphasis on theological education for the sake of marginalized Christian communities—especially Latinx communities.

When I began my PhD, I took teaching opportunities where possible to this end—I taught Bible courses for the UMC's course of study program in English (Introduction to Bible, Wesley Theological Seminary, 2020) in Spanish in the USA (*Profetas, Salmos, y Literatura Sapiencial; Torá y la Historia de Israel*, Perkins School of Theology, 2019-2020) as well as in El Salvador (*Profetas, Salmos, y Literatura Sapiencial*, 2019). I taught in Spanish for Duke Divinity School's Hispanic Latino Preachers' Initiative (*Introducción al Antiguo Testamento*, 2021) and in English at Georgetown University (Introduction to Biblical Literature, 2020-2021), Princeton Theological Seminary (Biblical Hebrew Translation, Deuteronomy and the Construction of Racial/Ethnic Worldviews, and Latinx/a/o Biblical Criticism and Exegesis, 2021-2023), and at Vancouver School of Theology (Deuteronomy and the Construction of Racial/Ethnic Worldviews, 2023). My current position at Reed College is in the Religion Department with an emphasis on the intersection of the Hebrew Bible and Race/Ethnicity. My courses for the fall are Introduction to Hebrew Bible and Bible, Race, and Empire.

Beyond my work teaching in and out of academic settings (whether traditional or no), I have also attempted to bring my research on ethnicity, race, and Pentateuch to congregations where possible. In February of 2023 I gave a talk with TheoEd titled "Biblical Interpretation as Making Tortillas." In the Spring of 2021, I was a guest lecturer at Nassau Presbyterian Church and Dutch Neck Presbyterian Church on "Ethnicity and Old Testament Interpretation." In early 2021, I was a guest preacher at Chevy Chase Presbyterian Church during their "Season of Justice—Theologies of Liberation" sermon series.

COMMISSION ON PREPARATION FOR MINISTRY

The commission reports that they completed an annual review with Candidate Melissa Temple on April 9, 2024. Melissa's growth objectives have been updated and she remains under the care of the CPM.

Desiree Ocampo, Candidate

The commission reports that they completed an annual review with Candidate Desiree Ocampo on May 14, 2024. Desiree's growth objectives have been updated and she remains under the care of the CPM.

Explanation of Process

The Book of Order outlines a process for individuals seeking to become a Minister of Word and Sacrament in the Presbyterian Church (USA) which requires a minimum of two years and contains eighteen separate steps. It involves the individual, the session of the individual's home congregation, the presbytery's Commission on Preparation for Ministry [CPM], the presbytery of call and the presbytery of care. Specific details can be found in the Book of Order G-2.06.

Applicant Process: The individual must be a member of a congregation for at least six months. The individual informs the session of their desire to pursue ordained ministry. The session notifies the CPM who then meets with the session for orientation on the inquirer/candidacy process. The session meets with the individual and makes a recommendation to CPM. This recommendation, along with the individual's application, references, and a psychological assessment is shared with the CPM who then interviews the individual and makes a recommendation to presbytery to enroll the person as an inquirer.

Inquiry Process: Currently there is 1 person in Cascades Presbytery enrolled as an Inquirer. This phase of the process is a time for exploration of the vocation of ministry and the sense of one's call to ordained ministry. Each person is assigned a liaison from the session of the home congregation and from the CPM. Once enrolled as an inquirer, an annual consultation is held for as long as the individual remains in the candidacy process with goals set in five key areas: education forministry, spiritual formation, interpersonal relations, personal growth and professional development.

Candidacy Process: After a minimum of one year, the inquirer can request to be moved to the candidacy phase of the process. The individual again officially meets with the session of the home congregation which makes its recommendation to CPM. CPM also meets with the candidate, reviews the progress made in the inquiry process, and receives the individual's one page Statement of Christian Experience. CPM then makes its recommendation to presbytery to enroll the individual as a candidate. Currently there are 3 individuals in Cascades Presbytery who are enrolled as candidates. This phase lasts a minimum of one year. During this time, the individual is given permission to take the five ordination examinations required by our denomination.

Certified Candidacy Process: Once the individual has passed those examinations, has taken a field experience and clinical pastoral education credit and is close to graduation from a Presbyterian seminary [or granted an exemption from the CPM on a case-by-case basis], the candidate appears before the CPM to be examined as certified ready to receive a call. This final assessment of the individual reviews all pertinent information from the entire candidacy process. The individual is also required to produce an exegetical paper and preach before the commission a sermon based on that text as well as defend a one-page Statement of Faith. CPM then is granted the power by operating procedures of Cascades Presbytery to approve a person certified ready to receive a call. Currently, 0 of the 3 candidates under care of Cascades Presbytery, are certified ready to receive a call. When a candidate becomes certified, they are given permission to circulate a Personal Information Form [PIF] and pursue a call.



Once a call has been extended to a validated ministry, the individual must appear before the presbytery to be examined on their Statement of Faith. This is the final step in the "trials for ordination" and is ordinarily conducted by the presbytery in which the call has been issued. Once examined and approved for ordination, the presbytery of call then ordinarily sets the time and place for the candidate's service of ordination.

Anytime during the process, an individual may request to be removed from the covenant relationship.
