### PRESBYTERY OF THE CASCADES MINUTES OF STATED MEETING April 19-20, 2024

A Stated Meeting of The Presbytery of the Cascades was held on April 19-20, 2024, at Westminster Presbyterian Church, Portland, Oregon. The Reverend Jennifer Martin, 2023-2024, Moderator of the Presbytery, was in the chair and the Reverend Paul Belz-Templeman, Stated Clerk, was present recording the proceedings.

Article VI.C. of the Presbytery's Bylaws states that the quorum for a meeting of the Presbytery, whether stated or special, shall be no fewer than the number of ruling elders required to represent at least ten percent of the congregations of the Presbytery, and an equal number of teaching elders of the Presbytery. At the time of the meeting, the Presbytery was composed of 90 congregations. Thus, the quorum for this meeting was 9 ruling elders representing 9 congregations of the Presbytery and an equal number of minister members.

**160** presbyters registered attendance at the meeting. Presbyters in attendance were **87** minister- members of the Presbytery, **59** elder commissioners from **41** of the congregations of this Presbytery, and **14** elders enrolled as commissioners by virtue of Presbytery service. A list of the Presbyter's registering attendance is attached as **Appendix A.** 

The meeting was convened at 2:05 pm by Moderator Martin as the Presbytery called itself to worship with the hymn for the meeting "Jesus Be With Us", litany and prayer.

### Welcome & Land Acknowledgement

The Reverends Beth and Gregg Neel welcomed the Presbytery to Westminster Presbyterian Church and acknowledged that the meeting was on the traditional village sites of the of the Multnomah, Wasco, Cowlitz, Kathlamet, Clackamas, Bands of Chinook, Tualatin, Molalla, and many other tribes.

### **CONSENT AGENDA**

1.) 403(b) MATCH FOR PRESBYTERY EMPLOYEES

Offer a 403B <u>match</u> of up to 4% to all benefited employees retroactively effective 1/1/24 to come into compliance with the IRS rules and regulations. Employees become eligible for this match when they become eligible for a pension plan (either Synod or Board of Pensions). Benefited ordained employees are eligible upon hire and benefited non-ordained employees are eligible at the one-year mark.

### Synod of the Pacific Commissioner

Bob Stebe, Commissioner from this Presbytery and current Moderator of the Synod, reported on the Synod's investment program noting that the money market rate was now 4% for congregations.

### Zephyr Point Presbyterian Conference Center

Executive Director, Dick Young reported on the activities of Zephyr Point and encourage attendees to consider a conference, program or stay at Zephyr Point.

### Conflict and Referral Team (CART)

Sarah Sanderson-Doughty, Leader of the Conflict and Referral Team, noted that the "R" in CART can stand for "Referral", "Resolution" or "Response". She noted that the team has been conducting interviews throughout the presbytery to understand the conflict that has emerged within and hoped to conclude this project in time to present conclusions at the Summer presbytery meeting in July.

### Confession & Grace

The Presbytery continued in worship with a time of confession and grace.

### Matthew 25 Movement

### Treasurer's Report

### Property Sale Income Allocations for Klamath Falls, Mt. Laki Sale

On behalf of the Board of Trustees, Chair Marilyn Howe moved, and after discussion, the Presbytery adopted, the motion to Suspend the Vacant Property Policy allocation of real estate sales for the net from the sale of Mt. Laki and distribute one third to unrestricted program reserves to offset the budget deficit, one third to replenish the Barnabas Grant Fund, and one third to the personnel endowment to offset future budget deficits.

After examination and discussion the Presbytery adopted the motion to **transfer Reverend Joan Schmidt into membership, enrolling her as a minister member of the Presbytery of the Cascades in accordance with the provisions of G-2.0505a(2).**

In anticipation of the Reverend Audrey Schindler's May 31, 2024, retirement, the Presbytery celebrated her ministry with litany and prayer.

The presbytery recessed for dinner at 6:06 pm and reconvened at 7:00 pm.

The Reverend Shavon Starling-Louis, Co-Moderator of the General Assembly, preached the sermon "Unbounded We Thrive" based on Micah 6:6-8 and Matthew 25:31-46.

At 7:45 pm the Presbytery recessed until Saturday Morning.

recommend that the Synod of the Pacific provide for the transfer of the Moro, Community (Sherman County), and Lakeview, First (Lake County), congregations to the Presbytery of Eastern Oregon with an overture the 226th General Assembly to approve the geographic district of the Presbytery of the Cascades as follows:

"The geographic district of the Presbytery of the Cascades consists of the county of Siskiyou (the census county division of Tulelake) in the State of California, the counties of Benton, Clackamas, Clatsop, Columbia, Coos, Crook, Curry, Deschutes, Douglas, Hood River, Jackson, Jefferson, Josephine, Klamath, Lane, Lincoln, Linn, Marion, Multnomah, Polk, Tillamook, Wasco, Washington, and Yamhill, all in the state of Oregon; and the counties of Clark, Klickitat (that portion west of the White Salmon River), and Skamania, all in the state of Washington."

### Laurelhurst Property to Native American Organization

After discussion, the presbytery adopted the motion presented by the Reverend Mark Olson that the Presbytery of the Cascades commits that if the former Presbyterian Church of Laurelhurst property at 935 NE 33<sup>rd</sup> Avenue, Portland, reverts to the Presbytery then the property will be transferred to an organization whose main purpose is to benefit Native Americans.

### Climate Vigil

Peter Fargo urged participation in the May 4<sup>th</sup> Climate Vigil at the Oregon State Capitol in Salem. The Climate Vigil was endorsed by the Presbytery at its June 2023 Stated Meeting.

### **Warm Springs**

The Reverend Beverly Crow reported on the work of the Administrative Commission for Warm Springs Presbyterian Church, recognizing the work of the church elders, inviting pastors to serve as pulpit supply as the church prepares to do \$150,000 in repairs on the manse in order to support a pastor who can live in the community.

### Communion and Offering

The Presbytery celebrated the Lord's supper with the Reverends Beth Neel and Sungmin Song presiding. The Vancouver Korean Presbyterian Church Choir sang the anthem and the offertory.

An offering of \$13,309.39 was received for Warm Springs Presbyterian Church toward its \$150,000 for the 150<sup>th</sup> anniversary campaign.

### Committee on Representation

Committee member Ted Envela reported on the work of the Committee on Representation and reminded the Presbytery that all of us come from God and have responsibility to be sensitive to what we say and the tone with which we speak. Ted noted that the purpose of the Committee on Representation was working to determine the demographics of the presbytery, the information will be kept confidential within the committee and the goal was to make sure that all were welcome and represented at the communion table.

Overture to the General Assembly: On Becoming Free from Plastic Pollution

The Presbytery concurred with the Overture to the 226<sup>th</sup> General Assembly "On Becoming Free from Plastic Pollution" which was presented by Jenny Holmes on behalf of Corvallis, First PC.

The concurrence was also supported by Beaverton, Southminster, Eugene, Central, Eugene, Westminster, Portland, Kenilworth, Walterville, McKenzie Valley.

Overture to the General Assembly: Protecting Utah's National Monuments and Wildlands
The Presbytery concurred with the Overture to the 226<sup>th</sup> General Assembly on "Protecting Utah's National Monuments and Wildlands for Ecology and Justice" which was presented by Jenny Holmes on behalf of Corvallis, First PC.

### Transitional Executive Presbyter Report to Presbytery April 19, 2024

As I sit down to write my first report, I realize that it has been exactly three months since I stepped into this new role as your Transitional Executive Presbyter. As one would expect, there has been a significant amount of information to get up to speed with, and as is true with any organization of our size, a lot of people to build relationships with. It has been a blessing to have worked in ministry in Cascades for over 25 years and to have some amazing relationships already in place, which has allowed me the advantage of not being as overwhelmed as I make new connections with our other presbytery leaders, staff, volunteers, ministry and ecumenical partners.

I was recently asked what my strongest impression has been in these first few weeks on the job, and one theme immediately came to mind: the great number of people who are giving of their time, talents and resources to fulfill the mission and vision of our Presbytery. Did you know that we currently have over 120

volunteers spread over a dozen committees, commissions, and teams? These amazing volunteers help support our tremendous staff to accomplish the needed work of our Presbytery. Many of these volunteers are contributing significant & valuable hours to help support not just our mid-council, but also to support the needs of the over 90 churches in Cascades. I want to be very clear... our Presbytery would not be able to live out our vision and our responsibilities without the sacrifices of our amazing volunteers and staff. So, from the bottom of my heart, I want to take a moment to say "thank you" to all of you!



The second impression I've had early on is how quickly the needs of our churches and our Presbytery have been changing. While the pandemic may be over, it brought about both new challenges and new opportunities. For some of our churches in Cascades, the challenges are universal... for others, the needs may be unique. We know that one size never fits all, so as a presbytery we need to take time to listen to all of our churches; to hear about current challenges and new opportunities, and in what ways we might be able to help with those evolving needs. The best thing we can do as a presbytery is to be listening, looking ahead, and making preparations to meet both the challenges and opportunities before us.

At the core of our DNA, Cascades has been a presbytery of collaboration and innovation. For decades, Cascades has served as a source of inspiration to others in the PC(USA) as we moved through changing religious and cultural landscapes. Presbyterians have always been a connectional church, and when we work together for our mutual needs, we in turn, become stronger together. This will allow us to more fully live into our core DNA and mission of cultivating Spirit-led collaborative ministries that embody God's love in Jesus Christ. This will need to be a team effort to be successful and should reaffirm our reality as a connectional church. I greatly appreciate your trust in the work ahead and look forward to more honest conversations together.

As an addition to the Commission on Ministry Report with all of its actions, I wanted to let you know about some behind the scenes work that has been going on to support the fluency of our presbytery meetings while also ensuring that our core values as a presbytery are being maintained faithfully, even in the midst of our rapidly changing world.

One area that has repeatedly arisen as a point of discussion, debate, and occasionally confusion is how pastoral conversions take place in our presbytery. As a starting point, a pastoral conversion is when a minister - serving in either an associate pastor position or a temporary pastoral relationship – has their relationship with their existing church changed. Some examples would include a supply pastor becoming an installed pastor, or an installed associate pastor becoming a pastor serving as head of staff for their congregation.

"Ordinarily," our Book of Order states, pastors in either associate positions or temporary pastoral relationships are "not eligible to be the next installed pastor of that congregation" (see G-2.0504 a and b, also printed below). While previously not allowed at all, and still not "ordinary" today, the Book of Order also recognizes that we live in somewhat extraordinary times. As a result, when the Book of Order was heavily revised in 2011 a provision was made for "Exceptions" to what had been a longstanding custom of our denomination. Section "c" of G-2.0504 states that "a presbytery may determine that its mission strategy permits a minister... to be eligible to serve as the next installed pastor. Presbyteries that permit this eligibility shall establish such relationships only by a three-fourths vote of the members of presbytery present and voting."

So, for over a decade, presbyteries have had the right - and the responsibility - to evaluate their mission strategy, consider the context of their local congregations, and vote with a supermajority to convert pastors to new installed positions within congregations if the church and pastor agree that such a change benefits their ministry. Such conversions are not a violation of our rules, nor a deviation from our order – they are an embodiment of our communal work to discern the Spirit's movement and respond faithfully in accordance with the parameters laid out in the Book of Order.

While pastoral conversion are fully provided for in the Book of Order, they do remain an exception to our normal and preferred patterns, and they do require a prayerful and deliberative process to be in place. Our Commission on Ministry's Transition Support Team has taken up the work of carefully evaluating our current procedure, as outlined in our COM Manual, Appendix 5E, and mapping out suggestions that would bolster our process in ways that will honor the high standards commended in the Book of Order, uphold our presbytery's commitment to equal employment opportunity practice and the priority of Spirit lead searches for pastoral positions, and hopefully reduce confusion on the floor of presbytery when conversions are requested. This process is still in the final stages of refinement, but will include the following general steps:

1. When a congregation or pastor expresses a desire to convert a pastoral call, the regional Commission on Ministry will schedule a meeting with the church's session and pastor. The congregation will be given the opportunity to appropriately weigh in on the potential change and signify its desire for such a change, and the regional COM shall evaluate if the mission strategy of the presbytery is enhanced by this potential change.

- 2. Assuming positive outcomes from step one, the COM will consult with the Committee on Representation (COR), evaluating how the initial search for the pastor was conducted and verifying that equal employment opportunity procedures were upheld. Further discussion and discernment with COR and the session will focus on the priority of conducting an open search versus the benefit of converting the current pastoral relationship. Priority will be placed on prayerful discernment of the wholistic needs of the congregation and the mission strategy of the presbytery, recognizing that the Spirit's leadership is the utmost priority in any pastoral call.
- 3. Should the COM and COR be satisfied with the desirability of converting the pastoral position, then the COM-CC will bring the request for exemption to the floor of presbytery for its vote. This request will most often come as part of an omnibus motion at the start of the business for the presbytery, reflecting the committed and diligent work completed in committee to fully understand the ministry context and needs of the local congregation. Should further debate be needed, members of the presbytery retain their right to remove the motion from the omnibus for further discussion, and both the COM and COR will be prepared to address questions based on their knowledge of the congregation and pastor, and will also be ready to recommend an affirmative action to the presbytery.

The intent of this modification to our current process is to create and orderly space for those called by the presbytery to serve on committees and commissions to complete full due diligence in advance of meetings of the presbytery, and thereby give the presbytery confidence that its values and priorities were carefully considered and upheld in the recommendation coming from the COM-CC. The hope is that with such assurance, requests for conversion that reach the floor of presbytery can be voted on with confidence by the presbytery since there is greater clarity around what steps have been taken to ensure that this exception is beneficial.

As we continue to live into these new days, marked by change and new patterns of ministry, I hope you know that there are many faithful, committed people, serving to the best of their abilities in support of the health and vitality of our many diverse ministries. I am continually amazed by the insight, creativity, and commitment of members of so many of our committees and commissions, and particularly by the Commission on Ministry and their three teams supporting Congregations in Transition, Conflict Resolution, and Care of Pastors. It remains a great honor to serve alongside you all, and in hope and trust for the ways God is leading us into this new season of ministry.

May God grant us all courage, faith, and love!

### **Book of Order Excerpts:**

### G-2.0504 Pastoral Relationships

When ministers of the Word and Sacrament are called as pastor, co-pastor, or associate pastor of a congregation, they are to be responsible for a quality of life and relationships that commends the gospel to all persons and that communicates its joy and justice. They are responsible for studying, teaching, and preaching the Word, for celebrating Baptism and the Lord's Supper, and for praying with and for the congregation. With the ruling elders, they are to encourage people in the worship and service of God; to equip and enable them for their tasks within the church and their mission in the world; to exercise pastoral care, devoting special attention to the poor, the sick, the troubled, and the dying; to participate in governing responsibilities, including leadership of the congregation in implementing the principles of participation and inclusiveness in the decision-making life of the congregation, and its task of reaching out in concern and service to the life of the human community as a whole. With the deacons they are to share in the ministries of compassion, witness, and service. In addition to these pastoral duties, they are responsible for sharing in the ministry of the church in councils higher than the session and in ecumenical relationships.

### a. Installed Pastoral Relationships

The installed pastoral relationships are pastor, co-pastor, and associate pastor. A minister of the Word and Sacrament may be installed in a pastoral relationship for an indefinite period or for a designated term determined by the presbytery in consultation with the congregation and specified in the call. When a congregation determines that its strategy for mission under the Word so requires, the congregation may call additional pastors. Such additional pastors shall be called co-pastors or associate pastors, and the duties of each pastor and the relationship between the pastors of the congregation shall be determined by the session with the approval of the presbytery. When a congregation has two pastors serving as co-pastors, and the relationship of one of them is dissolved, the other remains as pastor. The relationship of an associate pastor to a congregation is not dependent upon that of a pastor. An associate pastor is ordinarily not eligible to be the next installed pastor of that congregation.

### b. Temporary Pastoral Relationships

Temporary pastoral relationships are approved by the presbytery and do not carry a formal call or installation. When a congregation does not have a pastor, or while the pastor is unable to perform her or his duties, the session, with the approval of presbytery, may obtain the services of a minister of the Word and Sacrament, candidate, or ruling elder in a temporary pastoral relationship. No formal call shall be issued and no formal installation shall take place.

Titles and terms of service for temporary relationships shall be determined by the presbytery. A person serving in a temporary pastoral relationship is invited for a specified period not to exceed twelve months in length, which is renewable with the approval of the presbytery. A minister of the Word and Sacrament employed in a temporary pastoral relationship is ordinarily not eligible to serve as the next installed pastor, co-pastor, or associate pastor.

### c. Exceptions

A presbytery may determine that its mission strategy permits a minister of the Word and Sacrament currently called as an Associate Pastor to be eligible to serve as the next installed pastor or co-pastor, or a minister of the Word and Sacrament employed in a temporary pastoral relationship to be eligible to serve as the next installed pastor, co-pastor, or associate pastor. Presbyteries that permit this eligibility shall establish such relationships only by a three-fourths vote of the members of presbytery present and voting.

### REPORT OF THE TREASURER

### **Introduction to Presbytery of the Cascades 2023 Financial Statements**

The Statement of Financial Position and the Statement of Financial Activities below cover January through December 2023 and are generated from our ledger in Quickbooks. "Statement of Financial Position" is used by non-profits for "Balance Sheet" and "Statement of Financial Activities" is used by non-profits for "Income and Loss statement". These are similar to the statements with the same titles found in reports to Presbytery before 2019 (when we converted accounting systems).

We are continuing to track Program vs. Administrative income and expenses on the Statement of Financial Activities, and will continue to budget Administrative items vs. per capita income and Program items vs. Partnership Giving and other sources of revenue. During 2023, we recognized the totals expected for per capita income and Partnership Giving as income up front each year and then treat anything not collected yet as an Account Receivable. Look for the totals actually collected in the Giving to Presbytery Report below.

ICC Inter Church Center, the office building in Portland owned in part by the Presbytery and shared by local offices of four other denominations

**NCF** New Covenant Funds. New Covenant Funds are stock and bond investments held in the New Covenant Balanced Mutual Fund

**NMT** New Ministries Team

**PPG** Presbyterian Partnership Giving

PC Presbyterian Church

PF Account at the Presbyterian Foundation

**PF** (number) – Account at the Presbyterian Foundation whose account number ends in the three digits in the account name.

Fidelity Investments Main and Oakland Perpetual Funds are stock and bond investments under management of Headwater Investment Consulting, Inc.

### Appendix E Cont.

The New Covenant and Fidelity Investments together make up the bulk of our Reserves and Endowment.

As a reminder, the **Administrative Budget** is funded primarily by Per Capita payments from each congregation in the Presbytery. Per Capita payments support the Presbytery's administrative work. These funds:

- Fund the Stated Clerk's salary and half of the Administrative Manager's salary, as well as the Media Technician's salary
- Allow both the Presbytery and Presbytery Leadership Commission to meet
- Enable the Board of Trustees to manage the financial affairs of the Presbytery
- Fund any legal costs of the Presbytery and any other professional services required
- Pays for office overhead (phones, supplies, postage, storage, etc.)
- Pay administrative costs for Presbytery committee meetings meals, lodging and mileage

This Presbytery honors all Per Capita amounts payable to Synod and General Assembly without regard to whether a congregation withholds or pays less than its full share. Again, Per Capita is split up: of the total of \$45.60, \$30.53 is given to Cascades Presbytery, \$5.22 to the Synod and \$9.85 to General Assembly.

The **Program Budget** is supported primarily though the Presbyterian Partnership Giving (**PPG**), which is voluntary by our member churches. It includes the many activities that allow Cascades Presbytery to provide its mission, for example:

- Fund Presbytery staff to support local congregations and general administrative duties. This
  includes the two executive Presbyters, one half of the Administrative Manager's salary,
  the Bookkeeper, Commission on Ministry Team Leads, Missional Resource Manager, and Communications
  Manager
- Financial assistance to churches
- Emergency assistance to churches of all sizes (e.g., Barnabas Funds)
- Presbytery functioning in support of local congregations
- Care of congregations and pastors

We currently hold real estate in the form that came from dissolved congregations: the former Laurelhurst, Cherry Park, Colonial Heights and Cooper Mountain Presbyterian Churches. Laurelhurst and Cherry Park are currently generating revenue and so under Generally Accepted Accounting Principles (GAAP), we must take depreciation against them each year.



### Appendix F

### **Trustees Report**

### **FOR ACTION:**

The Trustees bring **two motions for action by presbytery** at this meeting. The action items are found in the body of the report.

The Board of Trustees held two stated and three special meetings since the November 2023 presbytery meeting.

### **Property Management and Sales**

### Leases:

### Approved and submitted to PLC for approval on behalf of the presbytery:

The Trustees approved leases between First Presbyterian Church, Astoria, and The Pacific Unitarian Universalist Fellowship and between Valley Community Presbyterian Church and Oregon Shalom Mission Church. Both were submitted to the Presbytery Leadership Commission for action on behalf of the presbytery at its March 13, 2023, and they were approved.

The Trustees approved a lease agreement between Grace Presbyterian Church, Portland, and The C<sub>3</sub> Church. The PLC approved this agreement on behalf of the presbytery at its April 10, 2024 meeting.

### **Property Sales:**

### FOR ACTION: Approve request to permit St John's Presbyterian (Camas) to sell two homes it owns.

The Trustees voted to recommend approving this sale at a special meeting held on April 5, 2024. The congregation no longer has the time or energy to manage two houses on property across the street from their building. The houses were purchased in anticipation of a need to expand parking many years ago. That plan was not implemented, and the congregation has been renting the homes at a below market rate as a mission to provide affordable housing in the community.

### Mt Laki Church Property Sale

The presbytery gave permission to sell the property of a dissolved congregation at its Special Meeting on Nov 28, 2023. We received a cash offer for the asking price (\$285K) in March from a private buyer that will donate it to become a Missionary Baptist church. The tenant living in the manse on the property will be allowed to stay in her home. The sale is scheduled to close on April 30, 2024.

### Colonial Heights, On the Market, But Damaged

Regrettably, the January storm damaged the vacant Colonial Heights Presbyterian Church in Portland building extensively. Pipes between the first and second floor burst, destroying ceilings, damaging all the interior walls, and light fixtures on the first floor of the building. The water damage exacerbated the existing mold problem caused by two roof leaks that had been present long before the storm. The presbytery's insurance claim for \$234K in damages was denied. A remediation company was working on the building, but had problems and work stopped in February. (POTC owes \$75K for that effort.) The building is uninhabitable and in such poor condition that our realtor advises against letting anyone tour it until it has been cleaned out. Despite this, we did receive an offer from a Montessori school, and inquiries from another private school and several congregations. We look forward to showing it to all who have expressed interest soon.

This situation demonstrates the risk of holding vacant property. The congregation stopped worshiping in the

building in 2022 and was dissolved at the January 2023 Presbytery Meeting. The Vacant Property Policy of the presbytery gives the new Ministries Team six months "to recommend to the PLC how property may be used as witness to Jesus Christ serving in the geographic area which it is located." In this instance, the New Ministries team requested and was granted an additional six months to work on an option that was eventually deemed not viable. If the property had been placed on the market last summer, when the New Ministries Team's first six months of exploration of future uses ended, it is likely the building would have been sold to the same party that made the offer we received. As it stands now, the net proceeds from the sale of this building will be hundreds of thousands of dollars less than it could have been.

### **Budget and Finance**

At our April 5, 2024, Special Meeting, the Trustees voted to bring the following motion to the Presbytery regarding the proceeds of the sale of the Mt Laki property:

FOR ACTION: Suspend the Vacant Property Policy allocation of real estate sales for the net from the sale of Mt Laki and distribute one third to unrestricted program reserves to offset the budget deficit, one third to replenish the Barnabas Grant Fund, and one third to the personnel endowment to offset future budget deficits.

The Trustees believe this motion to be the best use of these funds at this time, even though it does not fall in line with the distribution described in the Vacant Property Policy. This allocation addresses the three most immediate needs within the presbytery.

Our projected budget deficit for the current year is nearing the \$200K. The other grant programs funded by real estate sales have healthy balances, but the Barnabas Fund has been depleted severely. Future budget deficits will likely be as large or larger than the one we face this year, as congregations continue to shrink and partnership and per capita giving shrink with them. We need to take measures to build our investment accounts when we can so that we can reach a sustainable position.

The distribution of funds from real estate sales is part of a larger issue needs to be addressed. A budget task force is wrestling with this larger issue and we look forward to hearing their recommendations to make changes necessary to produce a viable budgeting process that addresses the sporadic income from property and the presbytery's expenses.

### **Grants and Loans**

### **Grants:**

The Trustees facilitated six grant requests to Presbyterian Disaster Assistance for six congregations that sustained significant damage to their buildings during the week-long January ice storm. The congregations received a total of \$22K. We are thankful for the diligence of staff member Thomas Lundy, who collected information from the congregations and made the requests on their behalf.

In normal business, the Trustees approved:

- A \$7500 Vitality Grant to the Presbyterian Church of the Siuslaw for an indoor play area to facilitate closer relationships with neighborhood families.
- A \$10,000 Vitality Grant for Hope Korean Presbyterian Church to help purchase a church van.
- A \$4410.60 Barnabas Grant for Malin Basin Community Presbyterian Church to repair its manse.
- A \$5,415.91 Barnabas Grant to Reedville Presbyterian Church to repair its heating system.

### Loans:

The sole loan approved in this period was an unsecured \$24,999 Synod loan for First Presbyterian Church, Bend, to fund a portion of the cost of a new HVAC system.

### Partners for Sacred Places "Cohort"

Twelve POTC congregations participated in an eight-session program run by Partners for Sacred Places, a non-profit that specializes in helping houses of worship find appropriate missional uses of excess property. Because the M.J. Murdock Charitable Trust funded this program as a pilot for future workshops in the Pacific Northwest, there was no cost to our congregations that participated.

The congregations that participated are: Multnomah; Kenilworth; Rose City Park; First Presbyterian, Newport; Tri City Presbyterian Church; Aurora Presbyterian Church; First Presbyterian, Woodburn; John Knox; First Presbyterian, Medford; Emmanuel; Mt. Scott Park; and Rise Church. There were two participants from other denominations, Central Lutheran and First Congregational United Church of Christ, both in Portland.

The Trustees sought feedback on the value of the program and are exploring was to help the congregations involved make use of what they learned. Currently, we are working to supply guidance about circumstance that dictate what federal, state, or local property taxes may be due when a church rents space to a for-profit entity. This information will be available to all our congregations on the POTC website.

The Trustees also see the need to create an additional lease template that addresses renting space to a for profit tenant. Our stated clerk obtained the sample for-profit lease used by two presbyteries in Washington state. We will be working to create one for Oregon congregations in the coming weeks. We look forward to working with and learning more from our Partners for Sacred Places cohort congregations as they put what they learned to use.

Partners for Sacred Places is exploring the possibility of holding another set of workshops in the Pacific Northwest in 2024. We are tracking that effort and will keep the presbytery informed.

### **Commission on Ministry Report**

### For Action (requires two-thirds vote):

After examination of the Rev. Joan Schmidt, member in good standing of the Christian Churches and Churches of Christ, on her statement of faith and suitability of fit with our presbytery, transfer Rev. Joan Schmidt's membership and enroll her as a minister member of the Presbytery of the Cascades in accordance with the provisions of G-2.0505a(2).

- Rev. Schmidt has submitted a request for validation of ministry of her work serving as Lead Chaplain
  for Peace Harbor Medical Center in Florence, OR. The COM-C has approved this initiative as a
  validated ministry, pending Rev. Schmidt's examination and enrollment in the presbytery.
- The COM-CC has verified Rev. Schmidt's credentialing and good standing within the Christian Churches and Disciples of Christ, completed a criminal background check, and performed a professional reference check on Rev. Schmidt, in accordance with our Presbytery's policies. Likewise, Rev. Schmidt has received our Presbytery's policies on ethical conduct, and she has affirmed her willingness to uphold these standards.
- The COM-CC has evaluated Rev. Schmidt's educational background, professional training, and service in another denomination and deemed them to satisfactorily meet the criteria of ordination in the PC(USA). In accordance with G-2.0502a(2)- "A minister of another Reformed church who has been ordained for five or more years may be granted an exemption for some or all of the examinations required of candidates for ordination by a two-thirds vote of the presbytery"- the COM-CC requests that the Rev. Schmidt be exempted from all of the ordination exams required of candidates for ordination based upon her more than five years of ordained service as a minister.

### INTRODUCTION AND OVERVIEW OF COMMISSION ON MINISTRY

The Book of Order states that each presbytery shall develop mechanisms and processes:

- to serve as pastor and counselor to its ministers, commissioned pastors and certified Christian educators;
- to facilitate the relations between the presbytery and its congregations, pastors and certified Christian educators;
- to settle difficulties on behalf of the presbytery where possible and expedient."[G-3.0307]

Cascades Presbytery has delegated authority in these areas to five commissions: a Commission on Ministry (**COM**) for each of the four regions and the Commission on Ministry Coordinating Commission (**COM-CC**).

Each of the four **regional COM** is composed of equal numbers of ministers and elders from the region. These commissions have been authorized to:

- receive, dismiss and oversee minister members;
- approve and dissolve calls for pastoral service and invitations for temporary pastoral service;
- provide oversight of congregations without pastors;
- approve the establishment and elimination of pastoral positions;
- establish administrative commissions to ordain or install ministers of Word and Sacrament.

The COM-CC consists of the four regional COM chairs and presbytery elected staff. This commission:

- coordinates the work of the regions;
- deals with any presbytery-wide issues related to ministry;
- acts as a clearing board for appeals on decisions of regional COMs.

### Appendix G Cont.

The Commissions on Ministry have established a subcommittee responsible for the training and oversight of the presbytery's Commissioned Ruling Elders, known as the **Commissioned Ruling Elders Coordinating Committee (CRE-CC)**. The CRE-CC is comprised of one representative from each of the regional COMs, as well as one representative of the Commission on Preparation for Ministry (CPM), and is supported by the Advocate for Congregations and Clergy.

The Commissions on Ministry have also established <u>three non-regional based teams</u>, each led by a paid team leader hired by the presbytery. These three teams support the work of the Commissions on Ministry in **Conflict Management, Pastoral Transitions, and Care of Pastors.** (see below for names)

The commissions bring for **presbytery** action motions related to:

- permitting associate pastors to be eligible to serve as the next installed pastor or co-pastor;
- permitting a Minister of the Word and Sacrament employed in a stated supply pastoral relationship to be eligible to serve as the next installed pastor, co-pastor, or associate pastor;
- examining certified candidates for ministry in order that they might be ordained and installed in an approved call;
- receiving ministers of Word and Sacrament from other denominations for called positions;
- requests for administrative commissions for purposes other than ordination and installation.

Here are the four Commission on Ministry Regional Commissions and their Chair:

COM CENTRAL COM-NORTHWEST

Ruling Elder, Mike Hachquet, Chair The Rev. Jim Wallace, Chair

COM-NORTHEAST COM-SOUTH

In their work and recommendations, the Commission on Ministry is guided by the provisions of the Book of Order and Commission on Ministry policies as approved by the Presbytery of the Cascades as found in the Commission on Ministry Manual.

During all pastoral contracts and calls, the Commission on Ministry guides churches to demonstrate a commitment to our Affirmative Action and Equal Employment Opportunity policies, which can be found in section 2.3d, Appendix 6F and section 7.6 of the COM Manual.

These policies affirm that "The Presbyterian Church (USA) is firmly committed at the General Assembly, synod and presbytery levels to the principle of inclusiveness. The mid-councils of our church believe that the spirit of Jesus Christ and the Gospel calls us and enables us to be inclusive of all who will respond to Christ's call..." The affirmative action "involves positive action, sincere effort, deliberately including for consideration and inviting all whom Christ has called to serve."

To guide this effort, the COM Manual outlines the following procedures which shall be maintained in the calling of pastors:

a. The Commission on Ministry (COM) liaison consults with the session, congregation and the Pastor

Nominating Committee (PNC) about their responsibility for AA/EEO, and assists them in developing a plan of implementation. It is recommended that arrangements be made for an affirmative action interpreter to visit, to talk about the issues and their experience, and to answer questions. In order to proceed to pastor search, the session, congregation and the PNC shall each take action and authorize the clerk, moderator of the session, and chairperson of the PNC to sign off on the Ministry Information Form (MIF).

- b. The COM shall assist the PNC in developing non-discriminatory criteria for the selection of the pastor. Discrimination based on racial ethnicity, age, gender, marital condition or disability is illegal.
- c. The COM liaison, in the course of working with the PNC shall, when necessary, challenge the members to stay with their commitment and shall, when appropriate, help them face questions and feelings which arise.
- d. Before the PNC presents a name to the congregation, the COM liaison shall be clear that they are prepared to certify that the AA/EEO commitment has been followed in good faith.
- e. The COM liaison shall certify to the regional COM, who shall certify to presbytery that the requirements of AA/EEO have been met (see Appendix 6F: Exhibit 1 of the COM Manual).

For pastoral searches for Temporary Pastoral Positions, such as for Interim and Supply Pastors, that do not involve a Pastor Nominating Committee, the Commission on Ministry similarly takes steps "to assure that every search is conducted to fulfill AA/EEO requirements. Thus, every pastor, regardless of race, ethnic origin, sex, age, marital status, or disability will be assured equal consideration by each search committee."

Our Presbytery's commitment to Affirmative Action and Equal Employment is strong, and in each search, the Commission on Ministry strives to bolster this commitment by ensuring churches are aware of the policies, that the policies are being followed, and that together, our hiring practices are reflecting our mutual commitment to be inclusive to all who have sensed and responded to Christ's call.

# Rev. Joan Schmidt, Minister Member of Christian Churches and Churches of Christ

Motion passed to validate the ministry of Rev. Joan Schmidt as Lead Chaplain for Peace Health, Florence, OR, pending her successful examination by the Presbytery of the Cascades and approval for transfer of ordination and membership.

God is the greatest mystery. God is vast enough to encompass qualities that seem paradoxical to us; compassion and justice, righteousness and mercy, salvation and judgment, wisdom and an upside-down economy of salvation that is foolishness in human eyes. Questions and paradox need not be feared, but are a call to seeking deeper relationship with God and trust in God's love. Despite the disparity between God's perfection and humans' flaws, God loves us and wants to be in relationship with us. God has lovingly chosen to reveal God's nature through the Bible, prayer, experience, nature, art, and other human beings.

There is one God in three persons: Father, Son, and Holy Spirit. God is eternal, omnipotent, omniscient, omnipresent, and created all that is. Jesus is God the Father's begotten son, firstborn of all creation, fully human and fully divine, Savior, Redeemer, Conqueror, Friend, Brother, Godwith-us. Jesus is "the maker and model of our faith (Heb 12:2)," showing us how to live and work through his ministry and words on earth and in relationship with us today in prayer. Jesus reconciles us to God through his death, burial, resurrection, and ascension. The Holy Spirit has always called, comforted, guided and empowered those who love and follow God.

Human history is a record of God's love story with humanity. It is marked with God's unfailing faithfulness and humanity's failing faithlessness. Humans are made in God's image and thus are each precious and uniquely gifted. However, because humans all sin, they need salvation in death, burial, resurrection, and ascension of Jesus Christ to be restored to right relationship with God and one another. Salvation is also the opportunity to live and work in God's kingdom, in this world and the next.

God's creation is as connected and intricate as a spider's web; God has delighted in making it beautiful and marvelous. Like most of God's gifts to us, creation is a responsibility to cherish and nurture as well as a privilege to enjoy. We are part of it, connected to each other and to our world. God is also in it all; everything has some potential to connect us or teach us about God or each other.

Sacraments connect us with God spiritually and communicate a special grace through physical rituals. God's part is the grace and our part is obedience and desire to become more Christ-like.

- Communion: the Eucharist allows us to connect with God and with our community. It is a means of receiving grace, forgiveness, and healing. It is a remembrance of Jesus's death and a celebration and thanksgiving for Jesus's sacrifice for our salvation. It is meant to be practiced frequently and in community. It is Christ's table and all those who confess Jesus Christ as Lord and Savior are welcome.
- Baptism: initiation to the family of God and an important step in God's redeeming and transforming. It is the response of the Christian upon their conversion and decision to receive the gift of a new identity and salvation in Jesus Christ. The reformed tradition recognizes infant baptism as bringing a child into the family of God. It recognizes that God first chooses humans even before they can choose God. Physically, baptism is a sign and seal of salvation; spiritually, we participate in Jesus Christ's death, burial, and resurrection through the waters of baptism.

The work of the Church is to be the Body of Christ and the family of God. The Communion of Saints transcends time and space and doctrinal boundaries. The Church is Jesus's physical presence on earth and as such carries on his work in bringing forward the Kingdom of God. The Holy Spirit comforts, guides, and empowers the church. As individuals and as a whole, the Church must strive to live a holy life, worship God faithfully, and perform acts of justice and compassion. The Church has been charged with making disciples through prayer, teaching, work, and study of scripture. Participation in a local congregation offers us the opportunity to serve, to grow, and to disciple others as well as to engage in corporate worship. Worship is part of our calling and connects us to God and one another. Worship can include our daily actions and conversations as well as the obvious music and liturgy.

All scripture is useful in the life of the Christian. It is also transmitted through humans in a particular time, place, and culture. It is a gift God has given us to reveal God's nature, desires, and ways to us.

We are responsible for using all the tools, including study and the voices of Christian tradition, at our disposal to understand it. It is essential to understand scripture as a whole and take each passage in context as it contains checks and balances and self-interpretation. It is also important not to create immovable doctrines on matters not addressed in Scripture. Beyond these cognitive tools at our disposal, we must each listen to the voice of the Spirit as we interpret Scripture. Here, too, we need humility and wisdom as we interpret the Bible as a great community of faith, each bringing our own understanding and experience of the Spirit.

Proclamation is an essential function for all Christians; our words and our actions must proclaim the same message. It is an opportunity to share the overflow of our joy in Jesus Christ with others. We also proclaim God's truth in love to our world. Preaching is proclamation in worship. It should be based in scripture and the message should always include the Good News of Jesus Christ. Preaching is a significant responsibility and the preacher should bring the best of their intellect and creativity and diligence to the preparation.

God has promised to be present with us and to care for us for eternity. We don't know how or when our end will come as a species, but we have the promise that God will be faithful to us and the call to be faithful to God through whatever tribulations we experience. The same is true for me as an individual: some day I will meet my end, and God will be there to care for me. In the meantime, my job is to be faithful to my calling in Christ Jesus.

While it is valuable to be able to articulate my faith and theology, my relationship with the three persons of God is greater and simpler than my cognitive understanding and carefully crafted statement. It is the music I dance to, and it sounds a lot like "Jesus loves me, this I know, for the Bible tells me so." It is my life-task to learn and execute the steps to the dance that best express that truth.

#### Statement of Faith

The heart of my faith is my commitment to Jesus Christ as Lord of my life. Fully human, yet fully God, he is our teacher, our example, our redeemer. He is the one who preached good news to the poor, proclaimed release to the captives, who heals our diseases.

We have rebelled against our maker, and in the words of "A Brief Statement of Faith," "Refusing to love God and neighbor, corrupting ourselves, exploiting others and threatening death to the planet entrusted to our care." But even when we are faithless, God remains faithful still.

In God's time Jesus Christ became human and lived among us. He took upon himself the sin of the world. He chose to die, that Scripture might be fulfilled, that sin and death might be defeated. Through this birth, life, death and resurrection, He brings about the relationship between God and humanity that God always intended.

God's Word, Jesus Christ, comes to us through Scripture, our infallible rule of faith and life, as it is read and faithfully interpreted and through the sacraments.

As Jesus ascended into heaven He sent us the Holy Spirit, the comforter, counselor, the presence of God today, and at Pentecost the Christian Church came into being. Therefore, by his Holy Spirit, he also assures me of eternal life, and makes me wholeheartedly willing and ready from now on to life for him."

The PLC meets via Zoom on the 2<sup>nd</sup> Wednesday of each month and takes action on behalf of the Presbytery between its meetings.

#### **FOR ACTION:**

 Recommend that the Synod of the Pacific provide for the transfer of the Moro, Community (Sherman County), and Lakeview, First (Lake County), congregations to the Presbytery of Eastern Oregon with an overture the 226th General Assembly to approve the geographic district of the Presbytery of the Cascades as follows:

The geographic district of the Presbytery of the Cascades consists of the county of Siskiyou (the census county division of Tulelake) in the State of California, the counties of Benton, Clackamas, Clatsop, Columbia, Coos, Crook, Curry, Deschutes, Douglas, Hood River, Jackson, Jefferson, Josephine, Klamath, Lake, Lane, Lincoln, Linn, Marion, Multnomah, Polk, Sherman, Tillamook, Wasco, Washington, and Yamhill, all in the state of Oregon; and the counties of Clark, Klickitat (that portion west of the White Salmon River), and Skamania, all in the state of Washington.

#### Rationale

- 1. In the spring of 2022, Eastern Oregon Presbytery Executive Stephen Kliewer approached Cascades Presbytery, Presbyter Brian Heron proposing that "some of Cascades congregations could be better served by Eastern Oregon Presbytery".
- 2. Two things are driving this conversation about transferring churches. First, Eastern Oregon Presbytery has 14 congregations and is close to falling below the minimum of 10 churches needed to remain a presbytery. Secondly, small agricultural town churches in Central Oregon find a greater affinity with the churches in Eastern Oregon and geographically may be better served by associating with the Presbytery of Eastern Oregon.
- 3. Heron and Kliewer discussed which congregations might fit better in Eastern Oregon Presbytery and came up with five: Moro, Prineville, Mt. Laki, Basin Community and First, Lakeview.
- 4. Heron reached out to the five churches and 3 responded with interest in the possibility: Moro, Community; Malin, Basin Community; and Lakeview, First.

- 5. Upon recommendation by PLC, Heron, Kliewer and a representative from the Commission on Ministry visited the three congregations in late winter, 2023. Moro and Lakeview responded with enthusiasm at the possibility of switching presbyteries. Basin Community was reluctant to make the move. See full report here.
- **6.** Stated Clerk, Paul Belz-Templeman was tasked with moving this work forward. the sessions of the three churches were asked to vote on whether they would approve transferring presbyteries and report it back to the presbytery.

Basin Community's session voted to remain in Cascades.

First, Lakeview's session voted to concur with a transfer.

Moro's session met voted to concur transfer.

## Implications of the Proposed Transfer

- Cascades will reduce from 90 congregations to 88.
- Presbytery membership will decline by 73 members (Lakeview=34, Moro=39)
- Both congregations usually pay per capita. The amount of per capita presbytery will <u>retain</u> from these congregations in 2024 is \$2,198 (this is after the pass through to GA and Synod).
- Lakeview and Moro will likely receive the same or a higher level of service from Eastern Oregon Presbytery.

#### **Presbytery Boundaries**

The second paragraph on the presbytery boundaries does three things:

- It removes Lake and Sherman Counties from boundaries in line with the transfer of Lakeview and Sherman. The only PCUSA congregation in Lake County is Lakeview, First. The only PCUSA congregation in Sherman County is Moro, Community. If the transfer is approved these counties will be included in the Presbytery of Eastern Oregon boundaries.
- 2. It includes <u>Clatsop</u> County in the Presbytery Boundaries (Astoria and Warrenton) which was not included in the 1974 boundaries listed by the General Assembly.
- 3. It moves the far Northeast boundary from Rock Creek (which doesn't bisect the North Klickitat county line) to White Salmon River (which does bisect the county line). To be clear, Trout Lake, First remains in the Presbytery of the Cascades.

## **Effects of Affirmative Vote**

With an affirmative vote on this overture to the Synod of the Pacific, the will vote on the overture at its May 2 meeting and then, in turn, overture the General Assembly. The General Assembly meets this summer and can approve the transfer and the restated boundaries of the Presbytery.

At the November 3, 2023, Stated Presbytery Meeting the Presbytery tasked the Presbytery Leadership Commission with ensuring that the four conditions for the transfer of the Presbyterian Church of Laurelhurst Property were met. The four conditions were part of the following motion:

In the spirit of repair and healing toward the indigenous community, work toward the transfer of the site of the Presbyterian Church of Laurelhurst, Portland, to the Future Generations Collaborative for \$1, once the following conditions have been met:

- **1.** Receipt of satisfactory documentation that the entity receiving the property is duly incorporated and legally capable of owning the property.
- **2.** Receipt of satisfactory documentation that the property shall not be sold or otherwise alienated except to an organization controlled by Native Americans.
- **3.** Satisfactory legal documentation protecting Presbytery from future liabilities.
- **4.** With full adherence to the Transfer Agreement drafted by legal counsel working on behalf of the Presbytery of the Cascades.

On March 13, 2024, the Presbytery Leadership Commission determined that the four conditions for transferring the Laurelhurst Property had been satisfied and acted to complete the transfer of the property to Future Generations Collaborative.

A report on this action will be uploaded as a supplementary background paper before the stated meeting.

# 226th General Assembly Overture - Plastics

## For Action:

Concur with the "On Becoming Free from Plastic Pollution Overture" to the 226th General Assembly.

The Session of First Presbyterian Church, Corvallis requests that the Presbytery concur with this overture from the Presbytery of Susquehanna Valley:

#### **Overture: On Becoming Free from Plastic Pollution**

The Presbytery of the Cascades overtures the 226th General Assembly (2024) of the Presbyterian Church (U.S.A.) to commit ourselves as a church, a people of faith and a social organization embodying Christian values, to:

- 1. Encourage all our settings to commit to changing from a disposable culture to a reusable, sustainable one.
- 2. Encourage education within our congregations and in our communities to advocate for alternatives to single use plastics, whether through mitigation efforts and campaigns or by supporting local and state bans on single use plastics, and
- 3. Encourage all settings of the Church to determine the best pathway forward for strategies and actions to mitigate plastic pollution, using as examples the following resources:
  - a. The Story of Plastics, (95-minute documentary)[i]
  - b. Sierra Club Solutions to Plastic Pandemic[ii]
  - c. Ten Towns –Ten actions Toolkit of New Hampshire[iii]
  - d. National Environmental Education Foundation (NEEF): Join the Fight for Reducing Plastic Pollution[iv]
  - e. Break Free Plastics: resources, articles, list of the worst corporate polluters and suggestions for actions [v]
  - f. The Five Actions Congregations Can Take from the United Church of Christ[vi]
  - g. Presbyterians for Earthcare webinar and resources on becoming free from plastics[vii]
- 4. Reduce the use of single-use plastics and packaging.
- 5. Commend all settings of the church to join in possible opportunities for participation in addressing plastic pollution including to:
  - a. Encourage all settings of the Church to commit to change from the throwaway and disposable culture and consumptive practices to reusable and compostable products. [viii]
  - b. Encourage replacement of single use plastics such as cutlery, plates, cups, straws, lids, and bottles with bioplastics, reusable, truly recyclable (like aluminum or paper) or compostable substitutes.
  - c. Preach on ecological sustainability principles articulated by Sallie McFague on responsible use of ecological resources [ix] and the sustainable goal of mitigating single-use plastics.
  - d. Educate on the importance of mitigation of single-use plastics and plastic straws as well as plastic bottles at our churches, their events, and gatherings.

- e. Educate on the toxicity of plastic pollutions and microplastics to the health of our environment, to our own health, and the health of non-human life.
- f. Educate on policies and practices of local recycling and composting services and advocating for better practices.
- g. Organize low or zero waste events in collaboration with local organizations and infrastructures.
- h. Support businesses that use sustainable practices such as reusable containers and reusable bags.
- i. Participate in public cleanup of God's creation, including all bodies of water, parks, and beaches.[x]
- j. Install fountains for water bottles in church campuses, wherever possible.
- k. Actively support and lobby for local, state, national, and international legislation and policies that align with the intention of this resolution including bans of or fees on single use plastics.
- I. Encourage the Mission Responsibility Through Investment Committee of the PC(USA) to engage with companies and corporations to reduce their production and use of plastics, particularly eliminating single-use plastics wherever possible.
- 6. Acknowledge that accommodations in expectations need to be made for certain impacted groups such as those who are disabled or unhoused.
- 7. Encourage people in all settings to speak truth to the public square against plastic pollution of our planet.

# **Rationale**

The 222nd General Assembly overwhelmingly agreed that "caring for God's creation" should be part of our constitution and this received concurrence of 150 Presbyteries[xi]. Our Book of Order now states "God sends the Church to share in the stewardship of creation, preserving the goodness and glory of the earth God has made"[xii] and includes "caring for God's Creation" in the commitment to participate in Christ's mission. In keeping with this, all Presbyterians should seek to reduce the use of plastics, especially single-use plastics, in their homes, churches, workplaces, communities, states and nation.

In 2023, our sisters and brothers in the United Church of Christ (UCC) General Synod passed the overture "Free from Plastic Pollution: A Resolution of Witness".[xiii] We overture the 226th General Assembly (2024) of the Presbyterian Church (U.S.A.) to join them. The UCC's Rationale can be found in their Resolution.

The PC(USA) General Assembly has affirmed that creation care is a fundamental part of who we are as Presbyterians. The biblical mandate for the overture "On Amending G-1.0304, The Ministry of Members, by Adding "Caring for God's Creation"[xiv] by Dr. William P. Brown (William Marcellus McPheeters Professor of Old Testament at Columbia Theological Seminary) applies to our need to become free from plastic pollution as well:

The fundamental biblical mandate for creation care comes from Genesis 2:15, where God places Adam in the garden to "till it and keep it" (NRSV). A better translation from the Hebrew is "to serve it and to preserve it." In Genesis 1:26–28, God blesses humankind with dominion over the earth. Human "dominion" as intended in Genesis is best practiced in care for creation.

In Christ "all things hold together" (Colossians 1:17), and "every creature under heaven" is to receive God's good news (v. 23). According to Revelation, God's work in the world is "make all things new" (21:5), to bring about a new

creation that does not destroy the old but transforms it, renews it. If the church is the sign of the new creation, then the church must lead the way in caring for creation.

Since the UCC General Synod passed their Resolution of Witness, further evidence of the danger of plastics to God's Creation have been realized. Studies have found plastics in almost every food they tested, often at high levels.[xv] Water from disposable water bottles contains about 240,000 nanoparticles per liter.[xvi] Plastics in our bodies can have serious impacts on our health and inhaled plastics have been correlated with lung inflammation, shortness of breath and a higher risk of lung cancer.[xvii] These impacts disproportionately fall on vulnerable and disadvantaged communities. Mary Johnson (Harvard T.H. Chan School of Public Health) said, "Vulnerable populations are at even greater risk of the negative health impacts from the production, use and degradation of plastics".[xviii]

Approximately 99 percent of plastic comes from fossil fuels, generating 3.4% of global greenhouse gas emissions.[xviii] Petrochemical companies have undertaken a massive increase in plastic production referred to as "Plan B for the fossil fuel industry".[xviii] Expanded the use of plastics serves to increase demand for fracked gas.[xix] Leaked methane, the largest component of fracked gas, has 28 times as much impact on warming the climate as does carbon dioxide[xx] and is responsible for about 30% of the rise in global temperatures since the Industrial Revolution,[xxi] resulting in 2023 being the warmest year on record, by far.[xxii] And while governments and international bodies are trying to limit plastic production, petrochemical industries are working to weaken legislation and international treaties.[xxiii]

Currently, 430 million tons of plastic is produced yearly resulting in a production of 11 billion metric tons of plastic in the last century, surpassing the biomass of all animals on earth. Despite efforts to convince people recycling is effective, only 9% of the plastic ever produced has been recycled, and 19% has been incinerated.[xxiv] Plastics are now one of the largest environmental disasters on our planet, polluting the Earth we are passing on to our children and subsequent generations.

God placed Adam in the garden to serve it and to preserve it. It is time for the Presbyterian Church (USA) to preserve creation by becoming free from plastic pollution.

# 226th General Assembly Overture - Utah National Monuments

#### For Action:

On Adopting "Protecting Utah's National Monuments and Wildlands for Ecology and Justice"
The Presbytery of Utah overtures the 226th General Assembly (2024) of the Presbyterian Church (U.S.A.) to commit ourselves as a church, a people of faith and a social organization embodying Christian values, to:

- 1 join with denominations and faith leaders in the US and Utah who are urging the ongoing protection of the restored Bears Ears National Monument and Grand Staircase Escalante National Monument, by signing the Interfaith Joint Statement on the Care of Creation & the Perpetual Preservation of Utah Wilderness, for example.
- 2. ask the Office of Public Witness to advocate as a national body and on behalf of the PCUSA for America's Red Rock Wilderness Alliance and to advocate for tribal sovereignty in the co-management of Bears Ears National Monument.
- 3. encourage congregations, individual members of congregations, and Presbyteries to take the opportunity to listen and learn about Bears Ears National Monument from the tribes that proposed the monument and organizations that are working to protect this landscape, and advocate for the environmental justice issues involved.

#### Rationale:

The 222nd General Assembly agreed that "caring for God's creation" should be part of our constitution and this received concurrence from 150 Presbyteries[xi]. Our Book of Order now states "God sends the Church to share in the stewardship of creation, preserving the goodness and glory of the earth God has made" [xii] and includes "caring for God's Creation" in the commitment to participate in Christ's mission.

With this rationale we as Christians are called to care for all of Creation and respect the interdependent web of all existence of which our fragile Earth is a part. In the opening chapters of the Hebrew Bible, God creates the Earth before creating humanity and subsequently assigns to humanity the role of guardian of God's creation (Genesis 2:15). We have been taught – through the Gospel lessons of Jesus and the prophets of the Hebrew Bible– the lessons of pilgrimage into the wilderness and the vital role that an appreciation of God's magnificent creation can play in our own spiritual formation. Our stewardship of the Earth requires us to think deeply about the many ways in which our activities affect the planet, including through climate change, environmental degradation, and loss of biodiversity.

The urgent, existential threat posed by our warming planet and a 1,000-year drought disproportionally and negatively impacts the underserved, underprivileged and indigenous people. In Utah federal lands such as national parks, national forests, national monuments, and wilderness areas that make up 66% of the land area. Utah's wild lands contain some of the world's richest concentrations of sacred sites important to the spiritual well-being of Native American cultures that endure, despite challenges, including the Ute Indian Tribe, Ute Mountain Ute, White Mesa Community, Confederate Tribes of the Goshute, Skull Valley Goshute, Northwestern Band of the Shoshone, Paiute Tribe of Utah, San Juan Paiute, Pueblo of Zuni, Hopi Tribe, and the Navajo Nation. These lands are deeply valued by people from many different spiritual traditions as places of inspiration, connection, renewal, and solace.

These public lands also provide habitat for endangered or sensitive wildlife, including desert bighorn sheep, cougar, and the Mojave Desert tortoise, as well as for elk, deer, mountain lion, bear, coyote and many other animals. These public lands are at the heart of the Colorado River watershed, which provides water to 40 million people – making it the second largest source of freshwater in the United States. The publicly owned wild lands of Utah belong to everyone, and the protection of our public lands works to the benefit of current and future generations. The federal designation of publicly owned wild lands as national monuments or wilderness areas helps to provide vital protection for these sacred and fragile places. In Utah, America's Red Rock Wilderness Act embodies these protections. Within the State of Utah, Grand Staircase-Escalante National Monument and Bears Ears National Monument protect areas of outstanding natural beauty and the complex and sensitive ecosystems they encompass. Both national monuments also contain priceless and fragile paleontological, cultural, and historical resources. The preservation of these ecosystems and resources closely aligns with our Biblical mandate to preserve and protect God's creation.

- a) protecting God's creation,
- b) offering allyship and support with the people who call this area their sacred place and home,
- c) showing solidarity with the ongoing issues of ecological and cultural justice the Presbytery of Utah faces, both during the 226<sup>th</sup> General Assembly and beyond.

# FOR ACTION [consent agenda item 4]:

- a. Offer a 403B <u>match</u> of up to 4% to all benefited employees retroactively effective 1/1/24 to come into compliance with the IRS rules and regulations. Employees become eligible for this match when they become eligible for a pension plan (either Synod or Board of Pensions). Benefited ordained employees e are eligible upon hire and benefited non-ordained employees are eligible at the one-year mark.
- b. Request that the Presbytery Leadership Commission approve all conforming changes to terms of call and the Presbytery's Personnel Manual

#### Rationale

- All employees can already <u>contribute</u> to the 403B hosted by the Board of Pensions and managed by Fidelity Investments.
- The <u>match</u> portion of this benefit is not in compliance with IRS regulations. The IRS requires us to provide the same benefits for all employees in the same category of employment. Historically, we were providing a 403B match to, our Executive Presbyter and the Advocate for Congregations and Clergy. The Stated Clerk was offered this benefit as well, but at the time opted out. By not offering this match to all employees in the same category of employment, in this case our benefitted employees, the POTC is out of compliance.
- The P&A committee recommended that we pursue offering the 403B <u>match</u> to all benefited employees. To move this process forward, a small group (Brian Craker, Paul Belz-Templeman, Lisa Snodderly, Alan Brady, Chris Montovino) was formed to explore the requirements and the total cost to the Presbytery. That group and P&A recommended to PLC the following:
  - 1. To come into compliance with the IRS rules and regulations, POTC to offer a 403B <u>match</u> of up to 4% to all benefited employees retroactively effective 1/1/24.
  - 2. Employees become eligible for this match when they become eligible for a pension plan (either Synod or Board of Pensions). This means ordained employees are eligible upon hire and non-ordained employees are eligible at the one-year mark.
- The estimated (new/un-budgeted cost) to the Presbytery for 2024 for the 403B <u>match</u> will be \$13,829. This assumes a 4% match for all benefitted employees once eligible. For benefited ordained staff the 4% is based on total <u>effective</u> salary as defined by the Board of Pensions (effective salary does not include the "50% of SECA" offset that the presbytery pays to ministers). This requires adjustments to current terms of call since compensation is changed by this action.

# **Explanation of Process**

The Book of Order outlines a process for individuals seeking to become a Minister of Word and Sacrament in the Presbyterian Church (USA) which requires a minimum of two years and contains eighteen separate steps. It involves the individual, the session of the individual's home congregation, the presbytery's Commission on Preparation for Ministry [CPM], the presbytery of call and the presbytery of care. Specific details can be found in the Book of Order G-2.06.

**Applicant Process:** The individual must be a member of a congregation for at least six months. The individual informs the session of their desire to pursue ordained ministry. The session notifies the CPM who then meets with the session for orientation on the inquirer/candidacy process. The session meets with the individual and makes a recommendation to CPM. This recommendation, along with the individual's application, references, and a psychological assessment is shared with the CPM who then interviews the individual and makes a recommendation to presbytery to enroll the person as an inquirer.

**Inquiry Process:** Currently there is 1 person in Cascades Presbytery enrolled as an Inquirer. This phase of the process is a time for exploration of the vocation of ministry and the sense of one's call to ordained ministry. Each person is assigned a liaison from the session of the home congregation and from the CPM. Once enrolled as an inquirer, an annual consultation is held for as long as the individual remains in the candidacy process with goals set in five key areas: education forministry, spiritual formation, interpersonal relations, personal growth and professional development.

Candidacy Process: After a minimum of one year, the inquirer can request to be moved to the candidacy phase of the process. The individual again officially meets with the session of the home congregation which makes its recommendation to CPM. CPM also meets with the candidate, reviews the progress made in the inquiry process, and receives the individual's one page Statement of Christian Experience. CPM then makes its recommendation to presbytery to enroll the individual as a candidate. Currently there are 3 individuals in Cascades Presbytery who are enrolled as candidates. This phase lasts a minimum of one year. During this time, the individual is given permission to take the five ordination examinations required by our denomination.

Certified Candidacy Process: Once the individual has passed those examinations, has taken a field experience and clinical pastoral education credit and is close to graduation from a Presbyterian seminary [or granted an exemption from the CPM on a case-by-case basis], the candidate appears before the CPM to be examined as certified ready to receive a call. This final assessment of the individual reviews all pertinent information from the entire candidacy process. The individual is also required to produce an exegetical paper and preach before the commission a sermon based on that text as well as defend a one-page Statement of Faith. CPM then is granted the power by operating procedures of Cascades Presbytery to approve a person certified ready to receive a call. Currently, 1 of the 3 candidates under care of Cascades Presbytery, are certified ready to receive a call. When a candidate becomes certified, they are given permission to circulate a Personal Information Form [PIF] and pursue a call.

Once a call has been extended to a validated ministry, the individual must appear before the presbytery to be examined on their Statement of Faith. This is the final step in the "trials for ordination" and is ordinarily conducted by the presbytery in which the call has been issued. Once examined and approved for ordination, the presbytery of call then ordinarily sets the time and place for the candidate's service of ordination.

Anytime during the process, an individual may request to be removed from the covenant relationship.
