PRESBYTERY OF THE CASCADES MINUTES OF STATED MEETING January 29, 2025

A Stated Meeting of The Presbytery of the Cascades was held on January 29, 2025, on the Zoom videoconference platform. The Reverend Chris Murphy, 2024-2025 Moderator of the Presbytery, was in the chair and the Reverend Paul Belz-Templeman, Stated Clerk, was present recording the proceedings.

Article VI.C. of the Presbytery's Bylaws states that the quorum for a meeting of the Presbytery, whether stated or special, shall be no fewer than the number of Ruling Elders required to represent at least ten percent of the congregations of the Presbytery, and an equal number of teaching elders of the Presbytery. At the time of the meeting, the Presbytery was composed of 88 congregations. Thus, the quorum for this meeting was 9 Ruling Elders representing 9 congregations of the Presbytery and an equal number of minister members.

141 presbyters registered attendance at the meeting. Presbyters in attendance were **74** ministermembers of the Presbytery, **52** elder commissioners from **38** of the congregations of this Presbytery, and **15** elders enrolled as commissioners by virtue of Presbytery service. A listing of the Presbyters registering attendance is attached as **Appendix A**.

The meeting was convened by the moderator at 6 pm with a reading followed by prayer.

LAND ACKNOWLEDGEMENT

Since the moderator and tech team for the meeting were present at Tualatin Presbyterian Church, Tualatin, Oregon, the moderator acknowledged that this meeting of the presbytery, while being held virtually, was hosted by Tualatin Presbyterian Church, on the traditional homeland of the **Chinook**, **Atfalati and Kalapuya** people, and offered our gratitude to the elders, past and present, who have stewarded it through the generations.

EXECUTIVE PRESBYTER

Brian Craker reported on the work of the Conflict Mediation process and on the work of the presbytery to respond to changes in law that affect how churches minister to migrants and refugees.

ADVOCATE FOR CONGREGATIONS AND CLERGY

Clark Scalera reminded ministers and elders during this exhausting and difficult time to consider "what got you into this mess in the first place", or better, what prompted you to commit your life to Christ and to your service to the church.

RECOGNITION OF SERVICE-WAUGH & JACKSON SHAW

Evonne and Mike Hubbard recognized the Reverend Kathy Waugh for her longtime service as editor of the Omnibus, the presbytery's monthly online newsletter.

Brian Craker recognized Ruling Elder Linda Shaw for her work as chair of the New Ministries Team.

The moderator offered a prayer of thanksgiving and blessing for Kathy and Linda.

ELECTION OF TREASURER

Lisa Snodderly from the Treasurer Nominating Committee nominated Dave Baca (Portland, First) for Treasurer, Class of 2028.

Dave Baca was elected as treasurer, class of 2028 by ballot with 127 in the affirmative and 1 in the negative.

WARM SPRINGS

Jim Moiso reported on the continuing work at Warm Springs Presbyterian Church noting the generosity of the presbytery's churches and individuals in giving funds towards the 150th anniversary fund, the ministers who have been providing pulpit supply each week and the work of the Trustees towards getting the manse renovated. Jim noted that the members of the church are grateful for the support of the presbytery and the work of those providing pulpit supply.

BOARD OF TRUSTEES

Chair Marilyn Howe gave the report of the Board of Trustees and, on behalf of the Board, moved to temporarily suspend the Vacant Property Policy and distribute net income from the sale of Colonial Heights according to the Budget and Finance Committee's funding model:

- Allocate \$350,000 for Warm Springs Manse (unused funds from this allocation will go to the Barnabas Fund.
- Allocate \$110,000 to pay staff member occupying the manse for 6 fiscal quarters (manse is part of staff member's compensation.
- Allocate \$25,000 to provide financial review package for congregations needing financial reviews.
- Replenish Barnabas Grant Fund with \$150,000
- Replenish Communications Grant Fund with \$15,000
- The remaining funds (approximately \$282,000) will be placed in the Presbytery's General Endowment to be withdrawn in 2025, 206 and future years to offset any budget deficits.

After discussion the motion was adopted by ballot with 126 in the affirmative and 3 in the negative.

NEW MINISTRIES TEAM

Linda Jackson Shaw reported on the 1001 New Ministries process, noted that the team is in transition and will not be offering grants during an interim period. The work of 1001 New Ministry soma.digital to bring the gospel into the Virtual Reality Space was highlighted.

The report of the New Ministries Team is attached as Appendix C.

COMMISSION ON MINISTRY

The Reverend Ken Hood, Chair of the Commission on Ministry-Central, reported for the regional Commissions on Ministry.

On Behalf of the Commission on Ministry Northeast, Ken Hood moved to **grant an exception in accordance with G-2.0504c, in order that Westminster PC, Portland, Oregon's Transitional** [Temporary Supply] Associate Pastor, Rev. Lindsey Hubbard Groves may be eligible to serve as their **installed Associate Pastor.** After discussion, the motion was adopted by ballot with 120 in the affirmative and 0 in the negative.

On behalf of the Commission on Ministry, Northeast, Ken Hood moved to approve the ordination of Junha Kim, in order that he may be called as Associate Pastor for Youth, Mission and Community Engagement at Westminster Presbyterian Church, Portland, Oregon.

PRESBYTERY OF THE CASCADES MINUTES OF STATED MEETING 2025-01-29

After examination and discussion, the motion was adopted by ballot with 123 in the affirmative and 2 in the negative.

On behalf of the Commission on Ministry, Northeast, Ken Hood moved to **request that the Presbytery of the Pacific ordain Junha Kim on behalf of the Presbytery of the Cascades.** The motion was adopted by ballot with 119 in the affirmative and 0 in the negative.

On behalf of the Commission on Ministry Northwest, Ken Hood moved **to authorize and request the moderator of Presbytery to appoint, in consultation with the Commission on Ministry, Northwest, an administrative commission for Portland, Hope Korean, with original jurisdiction.**The motion was adopted by ballot vote with 114 in the affirmative and 0 in the negative.

The report of the Commission on Ministries is attached as Appendix D.

AMENDMENTS TO THE PCUSA CONSTITUTION

On behalf of the Amendments and Overtures Committee the Stated Clerk moved to concur with the General Assembly and amend F-1.0403 in the Book of Order as follows....The unity of believers in Christ is reflected in the rich diversity of the Church's membership. In Christ, by the power of the Spirit, God unites persons through baptism regardless of race, ethnicity, age, sex, gender identity, sexual orientation, disability, geography, or theological conviction. There is therefore no place in the life of the Church for discrimination against any person. The Presbyterian Church (U.S.A.) shall guarantee full participation and representation in its worship, governance, and emerging life to all persons or groups within its membership. No member shall be denied participation or representation for any reason other than those stated in this Constitution.

The motion was adopted by ballot vote with 110 in the affirmative and 7 in the negative.

On behalf of the committee, the stated clerk moved to concur with the General Assembly and amend G-2.0104b in the Book of Order as follows: Standards for ordained service reflect the church's desire to submit joyfully to the Lordship of Jesus Christ in all aspects of life (F-1.02). The council responsible for ordination and/or installation (G-2.0402; G-2.0607; G-3.0306) shall examine each candidate's calling, gifts, preparation, and suitability for the responsibilities of ordered ministry. The examination shall include, but not be limited to, a determination of the candidate's ability and commitment to fulfill all requirements as expressed in the constitutional questions for ordination and installation (W-4.0404), the Historic Principles of Church Order (F-3.01), and in the principles of participation and representation found in F-1.0403. Councils shall be guided by Scripture and the confessions in applying standards to individual candidates.

The motion was adopted by ballot vote with 102 in the affirmative and 10 in the negative.

On behalf of the Amendments and Overtures Committee the stated clerk moved to concur with the General Assembly and amend G-2.0901 in the Book of Order as follows: An installed pastoral relationship may be dissolved only by the presbytery. Whether the minister of the Word and Sacrament, the congregation, or the presbytery initiates proceedings for dissolution of the relationship, there shall always be a meeting of the congregation to consider the matter and to consent, or decline to consent, to dissolution. No non-disclosure agreement shall be allowable.

PRESBYTERY OF THE CASCADES MINUTES OF STATED MEETING 2025-01-29

A non-disclosure agreement, also known as a confidentiality agreement, is an agreement that outlines confidential lmaterial, knowledge, or information that is to remain confidential. Such an agreement binds the party or parties who have signed it and prevents them from discussing any information included in the contract with anyone not authorized by the agreement.

After discussion, the motion was adopted by ballot vote with 109 in the affirmative and 5 in the negative.

COMMITTEE ON REPRESENTATION

Linda Shaw reported on the scope of work given to the Committee on Representation and noted that the Committee would provide an open space at the March meeting using a Cultural Proficiency Exercise. A video provided by Committee member Joe Igla on how they continue their work on cultural proficiency was shared with the presbytery.

ADJOURNED

The meeting was closed with prayer by moderator Chris Murphy at 8:23 pm.

APPENDIX B- REPORT OF BOARD OF TRUSTEES

FOR ACTION

Temporarily suspend the Vacant Property Policy and distribute net income from the sale of Colonial Heights according to the Budget and Finance Committee's proposed funding allocation model.

Rationale

The Budget and Finance Committee allocation (which will be presented at the Presbytery Meeting) includes funds to renovate the Warm Springs Manse and pay six fiscal quarters of compensation for a staff member to work at Warm Springs; replenishes the Barnabas and CATT Grant funds; and sets aside some funds for a pilot project to help congregations that have not conducted required financial reviews in addition to the \$126,000 from this sale that the presbytery voted to use to cover the 2025 budget deficit in the November 2024 presbytery meeting. The remainder of the proceeds will be placed in the presbytery's general endowment and be used to offset future budget deficits. Having money set aside for future deficits will help keep per capita low while General Assembly decides if it will continue to rely on per capita or switch to a different funding mode.

FOR INFORMATION

Since our last Presbytery meeting in November, the Board of Trustees has been faithfully engaged in supporting our congregations and their members as we enter the new year.

On behalf of the Presbytery, the Trustees:

- approved a \$10,000 **Vitality Grant for First Presbyterian Church in Cottage Grove.** This grant aims to support the congregation's ongoing efforts to enhance its ministry and community impact.
- A Loan Renewal Application for Orenco Presbyterian Church's Synod Loans was reviewed and approved. The 20 year loans originated in July of 2014 and have a remaining balance of \$207,000. The Synod lists the presbytery as co-borrower on all loans. This loan ensures the church's financial stability as it continues its mission and ministry.

Additionally, we have signed documentation with our Realtors to put the former **Cherry Park Presbyterian Church property in Troutdale**, Oregon, on the market, proceeding with its sale. This decision reflects our continued efforts to steward the Presbytery's property assets responsibly and in the best interests of the full Presbytery.

The Trustees finalized a funding allocation plan for the net income from the sale of the **Colonial Heights** property. This plan will be presented for consideration and approval by the membership at this meeting.

Recognizing that a significant number of our congregations have not completed financial reviews or have done so inaccurately, the Trustees have begun developing a financial review package for congregations in need. This initiative is intended to provide clear guidance and resources to help congregations accurately complete their financial reviews and ensure financial transparency.

The Trustees remain committed to supporting the mission and ministry of the Presbytery of the Cascades through thoughtful stewardship and strategic decision-making. We look forward to continuing to support the mission and vision of the Presbytery of the Cascades in 2025.

FOCUS ON MINISTRY

soma.digital

Originally funded by 1001 New Worshipping Communities and our New Ministries team in 2023, and sponsored by First PC, Newberg, soma.digital's intent is to make new disciples of Christ by bringing the Word to the people in an online immersive, interactive and communal way. The decline in church attendance, accelerated by the pandemic, has led many people to seek spirituality online. While some find online worship convenient, it cannot replicate the depth of in-person church. This means the digital space is increasingly becoming a mission field, offering unique opportunities to connect with individuals seeking spiritual formation in immersive ways.

soma.digital (www.somadigital.org) believes that platforms like virtual reality (VR), with their ability to create visceral, interactive experiences, can engage people more deeply in their faith journey than passive content like YouTube or podcasts. This approach involves using 3D 360° video experiences to take individuals to real-world locations where they can witness God's work globally, helping them connect scripture and faith to their everyday lives. A video will be shared at the Stated Meeting demonstrating how they do it.

Authentic Hope Counseling

Originally funded by the New Ministries Team in 2020, and sponsored by First PC, Corvallis. The project was funded to address mental health concerns for community churches, pastors and community members at large. A board will be formed from partnering churches to create a B Corp for this project to grow the practice into a mental health center that will also provide training for peace-building skills in the community.

Matt Johnson, liaison to Authentic Hope, gives this update on the ministry 4 years later:

Authentic Hope update cont.

- Authentic Hope Counselling has moved into a new building
- They received a Synod Grant for a total of \$37,000 in support spread out from 2024 through 2026
- They have hired a new associate
- They have provided over \$17,000 in patient assistance for people who cannot afford counselling
- Their Peace Camp / Peace Ambassadors programs are funded through counselling proceeds
- 2023 Peace Camp involved 38 students and 35 volunteers
- Their "Peace Ambassadors" program needs further development

Exhibit A

Westminster PC, Portland, OR Session Installation Request for Rev. Lindsey Hubbard Groves

As the chair of the Search Committee that called the Rev. Lindsey Hubbard-Groves to Westminster 18 months ago, I have been asked to share why Lindsey was right for this call then, and why it's right to install her now.

We received Lindsey's PIF along with two others in the spring of 2023. On paper she looked very accomplished. And thoughtful. Even wise. In person she was all of that, and much more. Accessible and easy to talk with from the start, she put our committee at ease in her interview which included not only conversation, but caring, laughter, depth, and disbelief that somehow 60 minutes had turned into 90. With no regrets. In our interview, one of Lindsey's top skills (in her words) is "not knowing things." In the next hour it was abundantly clear that she actually knew a lot. Knowledge for sure, but how to listen, pay attention, and make each person at the table feel heard. Sometimes in the moment, other times 30 minutes later with a reference back to something that person had said. And the skill of "not knowing things" really meant sitting, listening, not assuming, or prematurely fixing, but working to understand other people and their concerns better. Following the interview and our debrief, I asked the committee to describe Lindsey in a word or two. This is what they said: sense of humor, caring, knows who she is, humility, comfortable in her own skin, trust, joy.

What more could we want in a "Temporary Supply Associate Pastor for Congregational Care"? Except maybe a shorter title.

As background, this position was originally posted as Temporary Supply to provide coverage for duties of a long-time associate pastor who had accepted another call, while also allowing WPC time to determine an appropriate staffing model. Now, 18 months later with a staffing study behind us, we as a congregation are excited to request removal of those first two words from Lindsey's title. We look forward to celebrating her gifts in an installed position.

Lindsey is an excellent fit for Westminster. Simply put, she has a pastor's heart. She has built meaningful and caring connections with a variety of congregants at all ages and stages. She brings her full self to our congregation, which encourages others to do the same. Lindsey preaches thoughtful sermons with the right mix of insight, humor, story, and questions. Sermons that inspire reflection, and at times change. In her daily interactions she brings a sometimes dry, sometimes wry, always kind sense of humor, and a calming presence to anxious situations. Congregational care personified.

On a practical note, our congregation has experienced much pastoral change in the past 2 years, and we are certainly growing our muscles of adaptation. That in itself is not a reason to say yes to installation, but as you can see there are no shortage of other great reasons.

Statement of Faith for Junha Kim

From the critical seed of belief in a God that is wholly concerned with the restoration of the kin-dom, my faith has developed over time to strengthen this belief and understanding of God. In the midst of a paradoxical and conflicting word, fractured by institutional and historical divides, my belief in God as the creator and originator of a universe that is *good* calls me to actively participate and invite others into the integral and communal work of restoration. I believe that the work of restoration is and has been actualized through the modeling of a community brought together by the life, death, resurrection, and love of Jesus Christ. From the Hebrew Bible through the Pauline letters, we find that Jesus is both wholly human and wholly God and has come to earth to *be* the restored kin-dom, to be the surety of what is and is to come, and to communally invite the world to be a part of that work.

I believe that by partaking in the bread of life and the cup of salvation offered and given to us by Jesus, we are given the necessary sustenance both for our own lives and for the life of the kin-dom. And through baptism, we affirm and claim this radical life of love, compassion, and healing modeled by Jesus as our own, affirming the invitation and our acceptance into this new way of life. When we are baptized, we acknowledge that the sustenance for this new life is the bread of life and cup of salvation.

I believe that the history of the world is fraught with moments and periods of further fracturing the inbreaking kin-dom, and through Jesus, we have been both redeemed to restore this work, and we have been entrusted to maintain faith that the redeemed kin-dom draws nearer and nearer to earth each generation. And I believe the Church represents that generational lineage – a lineage of believers across time who have participated in the work of the redeemed kin-dom, building a space for holistic healing, respite, and both individual and community restoration.

I believe that in the word of God, we can discover the kinetic and boundless revelations of God's concern for the world – expressed through unconditional love, mercy, restorative justice, and grace. I believe that within the narratives, stories, songs, psalms, hymns, and revelations found in Scripture, we are equipped to seek out not only its relevance to the historical and contemporary Church, but equipped to reclaim the interpretations of Scripture that have been used to marginalize, oppress, and enslave people groups over time. And through the Holy Spirit, people have been gifted with their respective skills, talents, perspectives, and tools to directly reject and oppose the misappropriation of Christianity, and instead bring more and more of the kin-dom of heaven to earth.

I believe that even amid forcible conversion, religious colonialism and imperialism, the truth in the word of God is and has been powerful enough to reveal itself. In the word of God, we discover a holistically inclusive and compassionate vision of the kin-dom that does not ignore, but transcends religious, cultural, and *human* divisions, and calls us to continuously reshape and reform our understandings of God, as God's created humanities and cultures continue to fracture. As followers of Christ, as members of the Universal Kirk, I believe our greatest call is to be a part of the work of offering radical community, to the work of restorative justice, and to the work of *being* the radical love of Jesus. The truth is there in the word of God, revealed to the many peoples across history as a scripture of liberation, restoration, and redemption, and through God, we have been created and called, through Jesus, ensured and invited, and through the Holy Spirit, equipped, to restore the world.

INTRODUCTION AND OVERVIEW OF COMMISSION ON MINISTRY

The Book of Order states that each presbytery shall develop mechanisms and processes:

- to serve as pastor and counselor to its ministers, commissioned pastors and certified Christian educators;
- to facilitate the relations between the presbytery and its congregations, pastors and certified Christian educators;
- to settle difficulties on behalf of the presbytery where possible and expedient."[G-3.0307]

Cascades Presbytery has delegated authority in these areas to five commissions: a Commission on Ministry (**COM**) for each of the four regions and the Commission on Ministry Coordinating Commission (**COM-CC**). Each of the four **regional COM** is composed of equal numbers of ministers and elders from the region. These commissions have been authorized to:

- receive, dismiss and oversee minister members;
- approve and dissolve calls for pastoral service and invitations for temporary pastoral service;
- provide oversight of congregations without pastors;
- approve the establishment and elimination of pastoral positions;
- establish administrative commissions to ordain or install ministers of Word and Sacrament.

The **COM-CC** consists of the four regional COM chairs and presbytery elected staff. This commission:

- coordinates the work of the regions;
- deals with any presbytery-wide issues related to ministry;
- acts as a clearing board for appeals on decisions of regional COMs.

The Commissions on Ministry have established a subcommittee responsible for the training and oversight of the Presbytery's Commissioned Ruling Elders, known as the **Commissioned Ruling Elders Coordinating Committee (CRE-CC)**. The CRE-CC is comprised of one representative from each of the regional COMs, as well as one representative of the Commission on Preparation for Ministry (CPM) and is supported by the Advocate for Congregations and Clergy.

The Commissions on Ministry have also established <u>two non-regional based teams</u>, each led by a paid team leader hired by the Presbytery. These teams support the work of the Commissions on Ministry in **Conflict Management and Care of Pastors**.

The commissions bring for **Presbytery** action motions related to:

- permitting associate pastors to be eligible to serve as the next installed pastor or co-pastor;
- permitting a Minister of the Word and Sacrament employed in a stated supply pastoral relationship to be eligible to serve as the next installed pastor, co-pastor, or associate pastor;
- examining certified candidates for ministry in order that they might be ordained and installed in an approved call;
- receiving ministers of Word and Sacrament from other denominations for called positions;
- requests for administrative commissions for purposes other than ordination and installation.

In their work and recommendations, the Commission on Ministry is guided by the provisions of the Book of Order and Commission on Ministry policies as approved by the Presbytery of the Cascades as found in the Commission on Ministry Manual.

During all pastoral contracts and calls, the Commission on Ministry guides churches to demonstrate a commitment to our Affirmative Action and Equal Employment Opportunity policies, which can be found in section 2.3d, Appendix 6F and section 7.6 of the COM Manual.

These policies affirm that "The Presbyterian Church (USA) is firmly committed at the General Assembly, synod and presbytery levels to the principle of inclusiveness. The mid-councils of our church believe that the spirit of Jesus Christ and the Gospel calls us and enables us to be inclusive of all who will respond to Christ's call..." The affirmative action "involves positive action, sincere effort, deliberately including for consideration and inviting all whom Christ has called to serve."

To guide this effort, the COM Manual outlines the following procedures which shall be maintained in the calling of pastors:

- a. The Commission on Ministry (COM) liaison consults with the session, congregation and the Pastor Nominating Committee (PNC) about their responsibility for AA/EEO, and assists them in developing a plan of implementation. It is recommended that arrangements be made for an affirmative action interpreter to visit, to talk about the issues and their experience, and to answer questions. In order to proceed to pastor search, the session, congregation and the PNC shall each take action and authorize the clerk, moderator of the session, and chairperson of the PNC to sign off on the Ministry Information Form (MIF).
- b. The COM shall assist the PNC in developing non-discriminatory criteria for the selection of the pastor. Discrimination based on racial ethnicity, age, gender, marital condition or disability is illegal.
- c. The COM liaison, while working with the PNC shall, when necessary, challenge the members to stay with their commitment and shall, when appropriate, help them face questions and feelings which arise.

- d. Before the PNC presents a name to the congregation, the COM liaison shall be clear that they are prepared to certify that the AA/EEO commitment has been followed in good faith.
- e. The COM liaison shall certify to the regional COM, who shall certify to presbytery that the requirements of AA/EEO have been met (see Appendix 6F: Exhibit 1 of the COM Manual).

For pastoral searches for Temporary Pastoral Positions, such as for Interim and Supply Pastors, that do not involve a Pastor Nominating Committee, the Commission on Ministry similarly takes steps "to assure that every search is conducted to fulfill AA/EEO requirements. Thus, every pastor, regardless of race, ethnic origin, sex, age, marital status, or disability will be assured equal consideration by each search committee."

Our Presbytery's commitment to Affirmative Action and Equal Employment is strong, and in each search, the Commission on Ministry strives to bolster this commitment by ensuring churches are aware of the policies, that the policies are being followed, and that together, our hiring practices are reflecting our mutual commitment to be inclusive to all who have sensed and responded to Christ's call.

Statement of Faith Rev. Lisa M. Robechek

Last edited in October 2024

I believe in one sovereign, almighty, and trinitarian God. With infinite imagination and wisdom, God created our world and everything in it.
